AKC Rule Change

The Delegate body at its March 2023 meeting approved a revision to **Chapter 11 Section 8** of the [Rules Applying to Dog Shows](#). This amendment has the effect of expanding the allowance for neutered dogs and spayed bitches to compete in Veterans and **all other single entry non-regular classes** at independent specialties and all-breed dog shows without competition beyond Best of Breed. **This rule change is effective June 28, 2023.**

This allowance is an option for clubs and notification must be printed in the Premium List if neutered dogs and spayed bitches are allowed to compete in Veterans and/or any other single entry non-regular classes at independent specialties and/or all-breed shows which do not offer any competitive classes beyond Best of Breed.

A few selected notes from our BCOA AKC Delegate, Katie Campbell:

This rule change will enable our extended community members with spayed/neutered Basenjis to exhibit in some of our favorite non-regular classes, (*such as a field trial class* or whatever the host club wants to title their non-regular class) - without having to be an aged veteran to do so.

Please note that:

- 1) This opportunity is only available when there is no further advance of competition offered beyond Best of Breed (no Group or BIS *competition* beyond BOB)
- 2) Like any other non-regular class, the eligibility parameters class (e.g. Field Trial class) must be listed in your P/L.
- 3) This rule change does not pertain to multiple-entry non-regular classes such as brace and team. (I have written documentation to confirm this from Alan Slay, Director of AKC Event Programs)
- 4) The rule change becomes effective for eligible shows held on June 28, 2023 or later.

Hopefully this will encourage our performance/companion owners to participate by exhibiting their spayed/neutered Basenjis at our specialties.

Elimination of Ownership Requirement in Junior Showmanship Made Permanent

The AKC Board of Directors approved a pilot program at their May 2022 meeting, which eliminates the requirement that a junior handler be an owner of the dog they are exhibiting. The pilot program has been positively received. The pilot program will remain in effect until July 1, 2023, when a permanent revision of the Junior Showmanship Regulations will become effective.

Per BCOA Ballot 2004-48, published in January 2005 Bulletin Board:

"BCOA members incurring expenses covering BCOA budgeted items during the fiscal year shall submit invoices to the Treasurer on or before March 1st of the next year to be eligible for reimbursement. Expenditures incurred by members that are not covered by the Budget shall require Board approval. These bills shall be submitted to the Treasurer on or before February 1st of the next year. Committee Chairs shall be responsible for notifying committee members to submit receipts for expenses within this time frame."

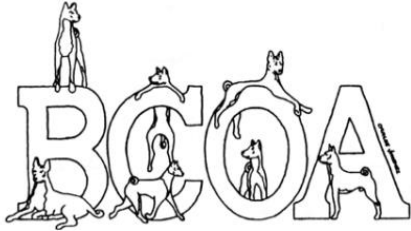
