She noted that the Lure Coursing Muzzle issue has been resolved to only allow basket muzzles, no fabric/no bite muzzles will be allowed. AKC is considering offering reserve best points to all clubs. This will come up in December at AKC Delegate Meeting. AKCTv is filming our National here. This is usually reserved for top 20 breeds but AKC agreed to film our event. It will be live and available on ACK site.

Yearbook – Mary Ellen Chaffin reported that she is interested in doing an annual yearbook again. She will need to be completely staffed before she will take on this venture. 
