Submitting expenses to BCOA Treasurer

Per BCOA Ballot 2004–48, published in January 2005 Bulletin Board:

"BCOA members incurring expenses covering BCOA budgeted items during the fiscal year shall submit invoices to the Treasurer on or before March 1st of the next year to be eligible for reimbursement. 


