

NEWS FROM GREAT BRITAIN

by Ernest Goodman 8 Hardy Grove, Folly Lane, Swinton, Manchester

Since my last report, a number of general championship shows have taken place within a short space of time. After Manchester the next show was the Scottish Kennel Club show, Edinburgh. The S. K. C. maintains its Basenji classes at this show in spite of the fact that the great majority, if not all of the Basenjis exhibited here come from south of the border and have to travel considerable distances, resulting always in a rather small entry - this year averaging 7 entries per class in 5 classes. The judge was the woman all-rounder Mrs. Thelma Gray, very well known in Corgis, Chihuahuas and Beagles. Best of Breed and dog C.C. went to Mrs. Cardew's young red and white dog ST, ERME PAINTED PONY, 15 months old. The bitch C.C. went to Mrs. Stringer's SIRDEEDE OF HORSLEY. 17 month red and white who also won her Junior Warrant on that day. Reserve C.C. dog was Mrs. Stringer's black and white SIR CECILTAR OF HORSLEY and in bitches Mrs. Butterworth's SONG BIRD OF ORLANDOS. Other first prize were Mrs. Stringer's black and white SIRVETAR OF HORSLEY in Novice, and Mrs. Butterworth's SYMBOL OF ORLANDOS in Yearling (between one and two years old). This show was on April 3rd.

The next show took place on April 24, at Boddington Manor, near Cheltenham - the first of the season's open air shows. Here there was an entry of almost 10 per class for the judge, noted all-rounder and gun-dog specialist, Mr. Frank Warner Hill. C.C. winner here were the same as at Edinburgh, SIRDEEDE OF HORSLEY once more taking Best of Breed. Reserve C.C. in dogs was Mason's REDESGARTH DAVIOT,

and in bitches, White's DORMTIKI QUOTA AZENDA. Other first prize winners were: Junior (under 18 months), Cardew's ST. ERME KIPUSHA; Novice, Butterworth's SONG BIRD OF ORLANDOS (bitch); Graduate, Ellis's tri-colour dog KHAN OF BASENLAKE.

At the next show, Leeds Championship show, held on the 30th of May, there was for the first time this year a breeder judge in the person of Mrs. C. M. Graham. It was also the first championship show appointment for Mrs. Graham, although, of course, she had served an apprenticeship by judging the breed at a number of Open shows. She must have been delighted to receive what was for this show, a record entry of 94 - an average of over 13 per class. Best of Breed went to the well-known tri bitch, Mrs. Gallagher's CH. ILONA OF MOCHI, piling up the C. C's. after a very long run of Reserves. The dog C.C. was the first by a comparatively new exhibitor and was won by Allen's red and white yearling, M'KOKO OF THE BAYENZI. Reserve C.C. in bitches was won from the Novice class by Diemell's SURREY OF NIANGARA. The winner of the Reserve C.C. in dogs was another making his debut - Macolm's REDESGARTH DENNY, Mrs. Cardew's ST. ERME PAINTED PONY won the Open dog class.

It was back to all-rounder judges for the next show at the beginning of June. The Chester Championship show where Mr. Jack Bower, well-known in terrier circles judged an entry of slightly more than 8 per class. Best of Breed at this show was Berry's CH. TOPFLIGHT OF SIN, with Reserve C.C. in dogs going to Ellis's tri KHAN OF BASENLAKE. The bitch C.C. (her second) was won by Bowers' DOMEWOOD PSYCHE, with Reserve C.C. to the same owner, THE ARDENT WOOER OF DOMEWOOD. The Puppy and Novice classes were won by Stringer's SIREUNICE OF HORSLEY, and the Graduate and (continued on page 21)

Our editor informs me of a number of requests on how to groom and show a Basenji. For this first phase, I will take you back to the November 1964 issue and reprint the article, "Some Tips on Grooming," by George C. Jones, III, of Atlanta, Georgia, from his early column, "Southern Exposure."


SOME TIPS ON GROOMING

"Taking a well groomed Basenji into the show ring is just as important as his conformation - if he is to win. Being a breed possessing very short hair, the Basenji is relatively easy to groom, and should take no more than fifteen to thirty minutes to prepare for the ring, assuming of course that the dog is clean. First I always start with the nails, and for this, I use the Resco nail cutter which is far superior to anything I have tried, and makes a nice, clean, even cut. Here however,

care must be taken not to remove too much of the nail. I always try to "hit" the quick, but never go beyond it. If the nails do bleed, the bleeding can be stopped by applying iron sulphate powder, or if that is not readily available, any powder (such as talcum) will work almost equally as effectively. From the nails, I go to the head and muzzle, where all whiskers must be removed. For this, I use a pair of Oster electric clippers, Model #A2, with a #30 blade attachment. After removing the whiskers, I use these same clippers and completely take all hair from the inside of the ears, and the backs of pasterns. To those of you who do not wish to invest in the Oster clippers (about \$50) a pair of manicuring scissors with curved edges will do the job with less speed. Here in the Deep South, we are not troubled by the untypical heavy coated Basenjis that are common in some areas. The thick undercoat can be taken out by using a Resco (or other make) stripping knife. This however, takes considerable patience on both the groomer and the dog. Next, comes the chalking. I have used many different brands of chalk, but have found nothing that comes even close to "French White" in (block form), manufactured by R. C. Steele Company in Park Ridge, New Jersey, as far as quality is concerned. The chalk is worked into all parts of the dog's coat where there is white, and then must be removed, using a small stiff brush, making certain that no chalk remains in the coat, as this can disqualify the dog in the ring. That just about covers it, except for a final touch of adding a small amount of oil to the dog's coat for added sheen. Here, I recommend either Bain de Soliel (a suntan oil) or Alberto VO-5, the latter being less expensive, and both give about the same results. A small amount is rubbed into the palms of the hands, and then over the dog's coat.

Good luck to you and your Basenji in the show ring." Next month will try to write on how to start your puppy on his way to his show career. Thanks, George for this one.

Since "The Basenji" must be read by each and every Basenji owner, this letter to the "Mailbox" is my initial step to voice an opinion on a matter I feel is important to all Basenji

Being a novice Basenji owner, I am fascinated by all that can be learned about this relatively new breed. One of my enjoyable pastimes is the study of Basenji pedigrees, which leads me to what I feel is a problem - the use of the "Of The Congo" to name dogs which are not from Veronica Tudor-Williams' kennels.

While tracing my bitch's pedigree, I wrote to Miss Tudor - Williams concerning one bitch registered "-- of the Congo." Having read "Basenjis, The Barkless Dogs," I had assumed that all "of the Congo" Basenjis were from her kennel. You can imagine my surprise to learn that this is not true! As Miss Tudor - Williams explained, any owner can use "of the Congo" when naming his dog. I was surprised even further to learn that Miss Tudor-Williams is not allowed to register her kennel name with the American Kennel Club because she is from another country. This is truly a shame after all she has done for the Basenji breed.

I realize that often newcomers to the breed are unfamiliar with all Veronica Tudor-Williams has done as well as being unfamiliar with any kennel names other than the one from which they purchased a puppy. Shouldn't some steps be taken against naming just any dog "of the Congo?"

Perhaps the first step should be an exception made by

the American Kennel Club not to allow anyone to register a Basenji as "of the Congo" unless Veronica Tudor-Williams is the breeder. Certainly there are other examples of infringing on an established name whether it be a kennel name or a frequently used term. Perhaps some kennels feel this makes their kennel widely advertised, but what about the person purchasing an inferior dog and using a well-known name; thus doing damage not only to the breed but one particular kennel!


Secondly, the Basenji breeders who should be better informed, could explain to new purchasers a few fundamentals of becoming better acquainted with the breed. Anyone who is familiar with "Basenjis The Barkless Dogs," and through "The Basenji," kennels should refrain from "stepping on toes" by trying to duplicate a name which could prove misleading.

Anyone who is the proud owner of a Basenji should be imaginative enough to choose a new and catchy name of their own. It would be a lot less confusing for pedigree study. . .

Most authorities on dogs claim that the Saluki probably is the oldest known dog. I, for one, have always questioned this, preferring to think the Basenji as the oldest, having lived among African natives who had no means of keeping records of the dogs. Now I have run across a statement supporting, if not accepting, my idea in "The World of Dogs," by Josephine Z. Rine, page 23, the author says that prehistoric dog could not bark, but it howled. This changed into a chortle, the intermediate vocalization. Then, the author states, the modern bark developed. It seems probable to me that a dog such as the Australian Dingo who can only howl would represent the first stage of vocalization, the Basenji representing the second stage, Telomian dogs (mentioned in the February 1970 issue)

Basenji litters have been arriving fast since my last notes, and excitement is running high in the Wellington area with more puppies being bred than ever before. Our own crazy household is 7 puppies richer. Our 3 1/2 year old son Lance is enthralled with the whole procedure. Informed his daddy the other night that he had a sore tummy. "I think I've got some puppies in there," he diagnosed solemnly.

Betty McMillan bred her tri BABY TRI IMPALA to ST. ERME MR. POLLY, and in the resulting litter were the first two tri-colours MR. POLLY has produced. Flora King from Golden Downs, reports the safe arrival of a litter by FULA-KIWI and KANDY OF KARIBA, including her first black and white. These recessive black and whites which develop some tan on maturity are cropping up fairly regularly in New Zealand. In fact, they seem to appear as frequently as tris.

While on the subject of colour, and now referring to red and whites, we personally found it difficult to predict the eventual coat colour on maturity. For example, taking two litters last year, one dog who has since sported the most wonderful orange/red coat; we have noted in our dog diary as being rather pale at birth. In the other litter, one bitch was almost black at birth, in fact, the first two days after birth we had difficulty in distinguishing her from a bitch which was black. She now has a brilliant orange/red coat too. It would be interesting to hear from other breeders on this subject.

In the latest New Zealand Kennel Gazette, there is a Statistics Table for all breeds registered during April 1, 1969 to March 31, 1970. Out of 79 breeds listed, Basenjis are in 27th place with 95 registrations for the year. Total registrations for all breeds are 10,405.

BASENJIS IN FRANCE

I was just finishing a letter to one of my American friends when the phone rang. At the other end of the line was Patricia Dhorne, phoning from Nice Airport before taking a plane to Barcelona with CLIPPER, GLOW and a Chihuahua. She had forgotten GLOW'S rabies certificate, vital for entry to Spain. It was too late for anyone to get the certificate down to her in time to catch the only plane of the day.

"Leave GLOW behind," I told her. But the authorities had insisted there was little chance of GLOW being impounded, particularly as it was a dog show, so I was told not to "casser la tete" - a message would go through to customs in Barcelona and all would be well.

The only trouble was, it was noon and everyone seemed to have forgotten that in Spain on summer afternoons nothing happens but 'la siesta,' and no one and nothing functions for several hours.

Patricia went blissfully on, confident and dreaming of four lovely days in a country she hadn't visited before, and with only a few cool evening hours during the three days when the dogs had to be present at the show grounds. It was fiesta time, and it never occurred to her that anyone would doubt her integrity. With three pedigreed show dogs, obviously in the prime of health she never imagined anyone would question her forgetfulness, for it was nothing more.

That same day, France's General De Gaulle was also arriving in Spain. At the other end - and by car. I could not help wondering if formalities had perhaps been tightened up for a time because poor GLOW was impounded and never saw the show at Barcelona - neither did CLIPPER or the Chihuahua. They returned the next evening and all that had been at stake was lost before it had begun. Poor GLOW - luck really seems to bypass her this year although she did win her first GAC and CACIB certificates at Perpignan with her litter sister BAMBI going reserve.

Had a visit the other day from a Frenchman who claims he saw his first Basenji in Nice some thirty years ago. Upon recommendation from Maire of Berre (member of The Basenji Club of France), he had taken the trouble to visit us so he could see our dogs and compare them with the original. This dog, he told us, was easily twice the size of SIMBA and belonged to an Englishman who had brought him out of Africa. The

dog was said to have been about 6 years old at the time, was barkless and known at that time by the name, "Basenji." It was courageous and strong enough to fight lions. I had heard this claim on previous occasions, but had ceased to quote it after my Belgian friends had told me about the "Balikwekwe" who never hunted anything bigger than an antelope. To my query about Basenjis tackling a lion they had quite firmly refuted any such possibility, telling me with precision that the 'Lion Dog' was the Rhodesian Ridgeback. Now I'm wondering all over again and am finding it increasingly difficult to answer questions put to me. If only one of those ancient and illustrious Pharaohs would arise from his tomb and tell us just whether his favourite dog barked or not. It might help!

Iam reminded here of another interesting detail supplied by Mr. G. de Josselin who is convinced that the Basenji doesn't exist! He is prepared to consider the possibility of there being something similar and tells me he has seen them in the Uganda territory where they live (or did live), with their native owners who belonged to the Pygmy tribe known as the B'Senghi - and hence our word "Basenji" which is merely a deviation from the African. Personally, I am more inclined to believe what Mrs. Marie Ficks tells us in her interesting letter in the Mailbox of the May issue. She seems to be one of the few persons who has been able to prove a point, or are we all inclined to believe what suits us, I wonder!

Here is an additional item of news concerning the classification of Basenjis in Italy. In reply to a letter which I wrote to Italian Kennel Club, after learning of the switch over, their letter addressed to me states that during the remaining months of 1970, the Basenji will continue to be judged as a hound, but from 1971 Italy will adopt the new regulation laid down by the FCI. It will become a terrier, so keep those letters (continued on page 13)

VETERINARY JOURNAL

DIABETES CAN BE PROBLEM FOR PETS Diabetes in dogs and cats is the same disease which occurs in humans, but with less frequency. It has been estimated that approximately one dog out of a thousand, and

perhaps a little higher figure for the cat, has diabetes.

Many people refer to diabetes as "sugar diabetes," and since there are two types of the disorder, we will be concerned here with the type commonly known as sugar diabetes. The other type is more rare and will be discussed in a later column.

The result of diabetes is an elevation in the sugar content of the blood. The reason the blood sugar rises is a decrease in the amount of insulin secreted. Insulin is an enzyme secreted by the pancreas and necessary for the metabolism of sugar in the body.

When the pancreas is no longer able to secrete enough insulin to metabolize the sugar then the sugar content begins to rise. As the sugar content rises it eventually reaches a level where the excess sugar is eliminated in the urine. This is the body's way of trying to compensate for the increase of sugar and to maintain a normal system.

SUGAR CAN'T BE ELIMINATED

The urine is capable of carrying away some of the sugar but, with most diabetics, this is only a transitory help because, as the pancreas continues to degenerate, the kidneys are not capable of eliminating the sugar "... ast as the body makes it. If this condition continues without detection, the animal will eventually go into diabetic coma and die.

In dogs, the most commonly affected animals are the older, spayed females. In the cat, the most commonly affected are the older noutere, males. However, younger animals can

also be affected.

Symptoms of diabetes vary according to the stage of the disease, however, there are some fairly constant symptoms that are present in a majority of the cases. Among the symptoms are an increased appetite with a concurrent loss of weight, or an increase in the size of the abdomen with weight loss elsewhere. Water consumption increases and the animal may urinate while sleeping without being aware of the act. Vomiting is a symptom that is usually reserved for the very sick animal and by this time the appetite is usually depressed or completely absent. Some animals may show none of these symptoms and become sick very suddenly after a slow, but gradual decline in activity and vitality.

DIABETES DIAGNOSIS SIMPLE

Diagnosis of diabetes is simple and requires only a urine sample. While there are other conditions that may cause sugar to appear in the urine, by far the most common cause is diabetes. A follow-up test on the blood is then indicated to make an accurate diagnosis and to determine the extent of the disease. After the diagnosis has been made it is then necessary to institute a course of treatment aimed at replacing the insulin, regulating the amount of carbohydrates the animal consumes and adding liver protecting drugs to the diet.

The first step taken is to replace insulin so necessary for the metabolism of the sugar. Each animal's insulin requirement varies, the same as with humans. Therefore treatment begins by giving a low dosage insulin and checking the urine. The dosage is increased every day or two until the sugar begins to disappear from the urine, but not until it disappears completely, because it is necessary to keep a small amount of sugar in the urine for testing purposes.

Another important aspect of treatment is diet control. It is now known that it is most important to arrive at a stabil-(continued on page 35)

THE WESTMINSTER KENNEL CLUB CHANGES ITS ENTRY REQUIREMENTS

The Westminster Kennel Club has changed the entry requirements for its 1971 show to be held February 15 and 16, at Madison Square Garden

Dogs that have been credited with one or more championship points will be eligible for entry at the 95th consecutive annual Westminster Dog Show, A major point rating was required at the 1969 and 1970 shows.

The Dog Show Committee of The Westminster Kennel Club stated that: "Although we want to preserve the quality of our entry, we do not want our entry requirements to foreclose the possibility of as many dogs as we can accomodate to be entered at Westminster. We believe from our last show that we can conveniently handle up to 1,500 dogs per day, and that is what we hope to achieve by changing the entry requirements.

The total entry will be limited to 3,000 dogs. The twoday format initiated at the last Westminster will again be used. Dogs in the Working, Terrier and Non-Sporting groups will be benched and judged on Monday, and dogs in the Sporting, Hound and Toy groups will be benched and judged on Tuesday.

I have been receiving a bit of mail with a mention that the writer has been reading this column, so my thanks to all of you who have written - both of you! Actually there have been several who have written for one reason or another and here is a sample which Iquote in its entirely, received on a postal card which had not been postmarked: "Since you are pretty good at conducting contests - (I am?), why not find out what most Basenji owners consider the proper diet. Mine eats anything not nailed down. And he's untrustworthy for sure." And it was signed simply, "Harassed. P.S. Like your column!"

I feel a bit like "Dear Abby" in replying to this one, but here goes - Dear Harrassed, whoever you may be or in whatever exotic, classified locale you might be located, your question was passed on to the readers and now we'll just wait and see what replies will come in. This could be an interesting topic as I know a number of breeders and none of them feed their animals the same diet. Similar, but not the same.

I also received a comment regarding umbilical hernias from Vada Zornick who enclosed items from several sources regarding this subject. The sources were page 72 of Veronica Tudor-Williams' book, "Basenjis The Barkless Dogs;" the Basenji column of Walter Philo in the March 1960 issue of "Pure-Bred Dogs, The AKC Gazette;" and an item by Norm Wallace in the November 1965 issue of "The Basenji." I had thought this information was generally known, but we often forget that there are new fanciers joining us each month and these may not have had the exposure yet. I shall attempt to summarize the information in the three publications so that the newer ones will be exposed and the old timers will be re-inoculted.

Umbilical hernias are rather common in Basenjis, becoming noticeable at several weeks of age. These have the appearance of small lumps in the area a puppy would have a navel. This may often be reduced or eliminated by placing the puppy on his back and gently pressing the lump back through the abdominal wall. This will have to be done a number of times until the muscles gain enough strength to retain the lump and seal it inside. If not attended to, the lump may grow to a thumbsized lump in the adult. It may be removed by surgery and will be shown as a fatty lump. In a few cases, this may be a serious problem should the intestines protrude through the opening. If this occurs and the muscles strengthen, it is possible to close the intestinal passage and death will result. Obviously this type of umbilical hernia needs veterinary attention as soon as possible. With experience one may be able to determine the difference himself, otherwise rely on your veterinarian.

Walter Philo quoted Dr. James Chapin of the American Museum of Natural History as saying that the standard of the Pygmies' Basenji Fanciers Association of the Ituri Forest indicated that the larger the hernia, the handsomer the dog! The English, Canadian and American standards ignore the subject as do most judges. If ringside spectators seem rather upset about the appearance of the protuberance, you might tell them it was a purse for the dog's mad money.

When one watches the vigor with which the bitch works at the sac enclosing the puppy and at the strength required to tear it to release the puppy, it isn't too surprising that such things happen.

Ramblin' With Grannie Green

"What has happened to the Basenji's wrinkles?" was one of the first questions asked of me when I interviewed Judge Ernest L. Masson of New Orleans, following his judging assignment at the Meri-Miss Kennel Club show, held on May 31, 1970, in Meridian, Mississippi.

It's a little difficult to explain to one who has not owned or bred Basenjis that our breed wears his wrinkles as humans do a frown or a smile. They are a facial expression, and a Basenji with the "mostest" can be bland when he chooses. Unfortunately he sometimes fails to oblige at the crucial moment.

Perhaps someone more versatile than I at repartee could have come up with a quick answer. I've seen this happen again and again, particularly in the show ring. A dog will appear devoid of wrinkles one moment, then his ring duties having been fulfilled, his wrinkles return full force. Now how do you explain that to a judge? I didn't!

Despite my having flunked the judge's first question, my interview with Mr. Masson was a delight. This is a learned man. Whatever he undertakes, whether it be in his profession of restaurateur or in his judging, it is done with profound and deliberate action. Even in casual conversation, Mr. Masson is not given to glibness. One finds himself bending to catch his soft spoken words.

It came my turn to interrogate the judge. His answers were deliberate and to the point. Mr. Masson feels strongly that sturdiness is an important quality in the breed. Next, movement, along with conformation, and in size to the standard is important. This he measures with his hands when he judges. To him, color is immaterial.

Whatever the breed, Mr. Masson emphasized that one must talk to his dog - communicate with him. As to breeding methods, he believes in what he personally practiced in his breeding and exhibiting days - genetics. We spoke generally of selective breeding to weed out faults, to strengthen good qualities, and the dangers of inbreeding too strongly toward good points. He reminded the writer that it is the dam who is dominant.

"Too many people today are in dogs for the money," the judge commented, "and care too little for producing sound dogs which conform to the standard." I am in complete accord

Mr. Masson came of a family of dog lovers. His father was a "Collie man." Following his marriage, Mr. Masson's bride who had never owned a dog, told him that she'd like a Scottish Terrier as a gift. So on the day their first son was born, Mr. Masson received word from a prominent Mississippi breeder that he had a puppy for him.

In 1930, the Massons ventured into breeding Smooth Dachshunds and upon retirement as breeders, had finished 22 champions. Mr. Masson thoroughly enjoys judging. Although he has not bredor shown dogs for a number of years, he speaks pridefully of Mrs. Masson's Miniature Wirehaired Dachshund who accompanies them on most of his assignments.

As we concluded the interview, Mr. Masson invited me to visit his restaurant on my next visit to New Orleans. I was already aware that Masson's Restaurant Francais on Ponchartrain Boulevard is famed for its fine French cuisine.

Thoughts Provokin'

ON THOUGHTLESSNESS

A recent trip to the grocery store revealed many things on man-unkind. A long line stretched back from the "express" check-out, waiting for a woman in shorts to finish her checkout. After all purchases were rung up, the cashier told her the amount due. She said, "How much is it?" And the reply was "\$2.60." With that the woman wrote a check for \$15.00!! A similar thing happened once more before I reached the cashier. I also noticed that a great number of women were there in shorts or slacks, and wearing curlers in their hair. Obviously they were not on their way home from work as I was. The grey-haired woman behind me made some comment about the check cashing routine to the effect that it was peculiar that the women had not had their checks OK'd before getting into line and why ask how much when they were writing checks considerably higher in value than the merchandise purchased. I agreed and wondered aloud about the number of women waiting until the rush-hour before shopping. The grey-haired woman agreed with my thoughts - although she was also attired in shorts and knit blouse. Actually, a poor choice of clothes for her figure!! Why are people so unthinking? Downtown shoppers always seem to wait until the rush-hour before heading for home - which increases an already huge traffic problem.

Obtaining service on one's automobile also reveals some intriguing thoughts on the part of service personnel. When they follow the manufacturer's service coupon to "check radiator," or "check windshield washer reservoir," this seems to mean to the mechanic to open the hood and see if the item is still attached to the vehicle. No one seems to bother replenishing the supply, if low. If they are so lax in their service on such simple matters, what does happen when a major item is involved, or have you ever considered that?

Government offices are no better. Drivers licenses, auto tags, etc., in many states must be obtained by appearing in person. And they are always open "for your convenience" between the hours of 8:30 A.M. and 4:P.M. - Monday through Friday. And it is very convenient, isn't it? Simply take some time off from your work. Has anyone ever considered that this means a drop in your income - and, incidentally, a drop in taxes received by the government also.

Dog show people, of course, are not this sort. They always think, don't they? Notice the obedience people demanding absolute quiet around their ring, but also notice their loud shouts of command and applause, etc., which could possibly affect dogs in the conformation rings. And have you ever walked your dog with a short lead only to have someone who has their dog on a long lead snarling at you to "Watch your dog!"

Parking is wonderful at dog shows. It is so convenient, especially when there are no attendants keeping you from parking close to the rings in which you may be showing. They usually send you as far away from where you'd like to go as is possible. And when the attendants are away for some reason, isn't it much nicer? Especially when you go back to your car to leave, knowing that you were in the second row and could back out, however, something has happened - you find you are in the middle of a three row parking lane, with cars fore-andaft of you. And the public address system is inadequate. Of course, dog show people aren't thoughtless - about themselves.

Superintendents and show secretaries are in the same category. Often you will find your breed the first judged - at 8 or 9 o'clock - at every show! Don't any of the other breeds rate an early showing? And how about the club that is having your breed's specialty show and you have the largest or second largest entry at the show. You usually end up benched as far away from the exhibiting ring as is possible.

Entry fees, food and drink costs, etc., are obviously the result of some very careful thinking - to charge as much as possible! And prize money has had careful thought also, but of a reverse nature, to give as little as possible. Many clubs keep insisting on making a profit on each and every show to allow their treasury to grow, but they have no plans for any of the money they have on hand which sometimes runs to several thousand dollars. Lest you feel this an uncalled for remark, I hasten to add that it is necessary for a show giving club to have a certain reserve in the event of a losing show - but 4, or 5, or more thousand dollars? With no plans for using the money?

Choosing judges to suit their own wants rather than judges who will properly judge all dogs (including those from the non-local area which are usually in the great majority) is also a common practice.

Wouldn't it be a much nicer world if all people thought? Of others, as well as of themselves? Try it sometime and see what happens. At least think about it. Many times we have said the same thing - and we shall continue to say it. In every phase of life - think! Through this column we hope you will see ways to do this. Or haven't you thought of it?



August - the month when everyone will be turning their attention to the breeding season just around the corner. What stud to use, and for what reason. A universal puzzle to be pondered and worked out.

The real disaster during the stud season lies in not knowing what is behind your dam and stud, genetically speaking. Do you have adequate knowledge of the background of the contemplated mating? Do you have access to photographs of these ancestors? Photographs are a poor second, but at least, they are better than nothing.

I cringe at the thought of people not being aware of their dog's heritage. I can think of many dogs right now of very shady backgrounds and yet these dogs in their own right have outstanding conformation, and their show records prove that, beyond a shadow of a doubt. So where is the problem? It's in not realizing that in the same litter with "CH. SEE-ME," your potential stud or dam, there was a pure white Basenji, or a spotted Basenji, or a couple with hip problems, or grossly mismarked puppies. When "CH. SEE-ME" is bred, the puppies can have these same problems. Iam not saying that "CH. SEE-ME" should not be bred. Quite the contrary - I am saying that it is the right of the potential litter owner to know that these problems exist. It is also the responsibility of the seller of any Basenji to inform the purchaser that certain problems are behind the intended purchase, and how to deal with these problems.

I was recently asked to intervene in a problem of this sort. A potential stud was about to be bred to a bitch that would in all probability have produced disastrous results. It was a clear case of the stud owner not being informed of the stud's background at the time of his initial purchase.

It is time Basenji breeders come out of their shells and accept the fact that we have certain breeding problems and that only positive action will overcome these problems. It is the universal attitude to hide from fellow breeders, the fact that you have produced black and white with tan, or hip problems, or eye abnormalities, or what have you. Don't hide these facts. Work with them. When it happens to you, don't curl up in terror and figure all the years of work have been wasted. Your breeding program is not going to produce any more (or less) of these problems than the next guy if you go about it intelligently. The difference is going to be in how you handle your problem. If you can't accept this situation, then for heaven's sake, don't breed!

My favorite hang-up these days is people who join a club, vowing to better the breed and uphold the standard and then in the next breath refuse to cooperate in the field of health and breeding problems.

Sorry to have got so worked up, but I figure I have another 40 to 50 years of breeding dogs ahead of me, and I just can't sit by and watch my chosen breed go down the drain because of a few people!

August marks six months on British soil and six months of glorious memories for Dion and me. By now we have gotten around to just about all of the Basenji breeders in this area, and have met the "Who's Who in Basenjis" and a few who aren't in Baseniis at all.

Next issue will be a report on two championship shows, The Hound Association show, with Judge Veronica Tudor-Williams, and Windsor, with Judge Mrs. Tress - her last assignment before leaving for her new home on Malta Island.





CURING PUPPY PLUMBING, GONE AWRY

Help Pup Stay Cool, Content in Hot Weather

Cool it! Is good advice for man and beast during the coming months. Your dog will keep comfortable and in good condition during summer's hot weather. All he needs is a little assistance from you. First, protect him from over-exposure to sun and heat. Dog yards and other outside enclosures must have shade. Shrubs do the job nicely and most dogs enjoy living on the cool earth underneath low hanging branches.

Benches or platforms provide shade and are sun decks on cool days. Never leave your dog in a car parked in the sun or with the windows closed. Heat prostration or suffocation are very real dangers in such situations. When your dog is a passenger, look for shady parking spots and lower the windows two or three inches.

Fresh water is another summertime "must." If your dog tends to bloat himself on water, offer ice cubes instead, once in awhile. He'll refresh himself without filling up with liquid. Ice cubes are handy thirst quenchers during trips, especially for dogs prone to motion sickness.

On hot days, cool your dog by wetting him down or wiping his face and muzzle with a damp cloth. Be sure his coat is dry before bringing him inside if air conditioning causes a sudden drop in temperature.

Should a heavy coated dog be clipped in the summer? Some owners think the coat is natural insulation against heat, as well as cold. Other owners feel a heavy coat adds to the dog's discomfort and encourages skin parasites. The Center suggests a midway approach: thin or trim your profusely coated pet, if you wish. He may be cooler this way and will be easier to groom and keep parasite-free. Don't shave off his

coat or clip it close to the skin, since this increases his vulnerability to the sun and biting insects.

Fleas and other skin parasites thrive in warm weather. As you brush the dog, ruffle his coat backwards against the skin to check for fleas and other pests. Try to spot them before the dog's scratching makes his condition obvious. Apply a good commercial parasiticide dip or power. Fleas can be removed from the coat with a fine-tooth comb. Also wash or replace the dog's bedding to eliminate parasite eggs that may be deposited in it.

Let your dog set his own pace. On hot days walk him in the early morning and evening when temperatures are coolest. Ask the children not to play too boisterously with their pet. Rough-housing or other exertion might bring on heat prostration. Be particularly cautious in this respect if your dog is old. overweight, or one of the short-muzzled breeds.

Heat prostration is indicated by excessively heavy breathing and panting, a glassy-eyed expression, lack of coordination and vomiting. Immediately get the dog in shade and sponge him with cool water. If he seems to be in serious trouble, put him in a tub of ice cold water, supporting his head above the surface. This, of course, is emergency first aid. Call your veterinarian for advice as soon as possible.

Hot weather may promote an indifferent appetite or digestive upsets. If your dog tends toward either condition, divide his daily meal into two or three portions. Smaller servings won't overload his stomach and may be more tempting to the dog.

He's much likelier to at when offered foods with canine taste appeal. Soft-moist products are highly palatable and digestible, both "plus" benefits for summertime feeding. In summer, as any time of the year, your dog needs the total nutrition which soft-moist foods provide.





August being the month of the stud issue of The Basenji, it seems appropriate to pass on a few helpful hints for making stud arrangements for your female.

After you have made the decision to breed your female, the owner of the stud should be contacted as soon as possible because others may have plans to use the same stud and most stud owners won't let their stud service more than two in one week's time.

Some of the most carefully planned events never take place, however, so it is a good idea to select a second choice in advance so you aren't looking for a stud at the last minute.

Ask advice from more experienced breeders if you have trouble selecting the right stud - most breeders will be happy to answer your questions and suggest a suitable stud for your bitch.

Persons owning a novice male that they would like to use for stud should use care when attempting to breed because an aggressive female will sometimes attack a strange male, therefore one should always hold the female before and during the actual mating. A young male will sometimes lose interest in breeding if once attacked and could ruin a good stud dog.

A stud agreement should be made in writing and be as complete as possible. We know of a case in another breed where it was agreed the stud owner was to have pick of the litter for the stud fee. The female produced a single whelp, and this puppy went to the owner of the stud. This was an unusual case, but it can happen. Ask the stud owner if he will guarantee more than one puppy or repeat the service if there is a litter of only one.

Much luck with your 1970 breeding plans!

. . . Mrs. Hill, couldn't you possibly devote at least one complete page to the novice breeder? It seems there are so many things that could make it easier for them. They have no Elsa Hubbard to call on as I had, so I had very few problems that seemed like mountains. Still there were things that even Elsa couldn't prepare me for. I read that article in "Popular Dogs," in the Basenji column for May 1970. Now, if in your magazine there had been a small item stating the harm of cow's milk to some puppies and that goat's milk is the closest to a bitch's milk. This may be expensive in some parts of the United States, but also comes in cans and could be fed to pregnant bitches and puppies until the puppies were on solid food. I'm sure she and a lot of others would have appreciated it. Also goat's milk must be purchased pasteurized for undulant fever from a goat is ten times more severe than from a cow. My veterinarian told me that. Also give puppies whole raw carrots to teethe on. Wood causes splinters, even the hardest and that may end in a perforated ulcer and death. All breeders, however great, start small and from the small ones come such kennels as yours and other important ones. True, some breeders are not serious enough to make a career out of it, but help is needed by the novice. . . .



FITTING A DOG FOR SHOW

by R. W. Kirk, D. V. M.

A presentation at Dog Health Seminar, O'Hare Inn. Chicago, Illinois, sponsored by Morris Animal Foundation, Denver, Colorado.

Each breed of dog was evolved for a purpose - in general those features which enhance that function should be emphasized for the judge. However, I despair sometimes at the extremes which become fashionable. The animal's best interests are not served by emphasizing such things as special folds of skin, wide shoulders and narrow hips, collapsed faces or peculiar angulation. If the fashion pendulum swings too far either way, health aspects can be detrimentally affected.

Except for a few breeds, a slight amount of extra fat is needed for best show ring appearance. However, the dog can't be flabby and he can't be a bundle of solid muscle - he must look "sleek." Walking exercise and good nutrition should be balanced to provide the best result. Some dogs are early maturing while others are "late bloomers." Force feeding and other tricks to fatten up the puppy for show should be avoided. They form bad habits and present the dog to the judge falsely. Wait until the pup matures adequately to show him at his best.

Foot care is important to develop "tight feet." Feet can be ruined by housing, on concrete or slick surfaces. Proper gravel is often ideal for runs as it forces the toes to exercise. While on gravel the feet may appear splayed, but once off it the toes tighten up nicely. Limestone surfaced runs may be bad for long hair breeds as it causes "chalking" and a broken coat.

Coat care is a special problem. In general, bathing should be kept to a minimum as it is drying. However, with long or kinky coats more frequent washing may be needed to

remove dirt and grit which have a severe abrasive action and may ruin a fine coat. Lots of combing and brushing should always be encouraged.

Diet is one of the paramount considerations in show conditioning. I am opposed to diet supplements, vitaminmineral mixtures, and coat-conditioner medications generally. In special cases they may be useful. A balanced food should be used as a basic diet and small amounts of special items added to "jazz up" the appetite appeal only if necessary. Most dogs are born with good appetites, but if we cater to them with special treats we form habits which cause future problems.

Getting a dog in top condition for show is a real challenge. Many dogs never obtain the bloom so admired. Many obtain it before or after the important date - this is one of the factors making shows fun and frustrating. It also explains one of the variables for different placings of the same competitors. These challenges will always make show competition an ex-

ized diet, with a minimum of carbohydrates, and to remain on this diet continuously. Animals do not require a change in diet and will very often eat the same monotonous diet daily, which makes it easy to control the diet of a diabetic pet.


