### COVER STORY

Shown on our cover this month is Best in Show Champion BETSY ROSS' KINGOLA OF BER VIC, winning Best of Breed at the Basenji Club of New England Specialty at Elm City Kennel Club on July 27, 1969, under Judge Dorothy Cass.

KINGOLA, the top-winning Basenji in the United States for 1968 (Phillips points), is owned by Betsy and Ross Newmann, BETSY ROSS KENNELS, 14801 River Road, Potomac, Maryland 20854, and is handled exclusively by Ross Newmann.

The first time KINGOLA was shown as a champion in October 1967, he won Best in Show at Queensboro Kennel Club in Long Island, New York, under Judge Isidore Schoenberg. KINGOLA recently won another Best in Show on August 29, 1969, at the Carolina Kennel Club, Greensboro, North Carolina, under Judge Haskell Schuffman.

1969 was a banner year for KINGOLA. He started out in February by winning Best of Breed and Group 4 at Westminster Kennel Club, Madison Square Garden. KINGOLA'S record for 1969 shows 42 Bests of Breed and 30 Group placements, including 8 Group firsts and 14 Group second wins.

KINGOLA'S record as a champion shows 79 Bests of Breed and 60 Group placements, including 19 Group firsts, 20 Group seconds, 12 Group thirds and 9 Group fourths.

In addition to KINGOLA'S outstanding wins for 1969, Betsy and Ross Newmann have been highly successful with two of their young Basenjis. One is BETSY ROSS' STORMI OF BER VIC who had 3 majors and 12 points at the end of November. The other is LUDDYMARIE BETSY ROSS MELISA who had 3 majors and 14 points at that date.

Still another winner owned by Betsy and Ross Newmann is CH. BETSY ROSS' NIKKI OF BER VIC (handled by Betsy Scheufele) who has had some nice wins on the West Coast.

### RACING BASENJIS

Alas, the Basenji racing season has come and gone. At the moment the season only lasted one day, but, at least, it's a start

The weather was good, fairly bright and sunny. The facilities were excellent, thanks to the kindness and generosity of the Afghan Hound Club of Canada, and in conjunction with the Greenwood Kennel Club, the Basenji racing took place on Sunday, October 12, at the Greenwood Raceway.

Considering the fact that we were using show dogs who have not been trained to wear muzzles or be put into a starting box, or indeed, to chase a fur lure, the racing was a success. Add to this the disadvantage of having very few volunteers to help, none of whom had the experience needed, and those who did help had been in the regular show and our second Canadian Specialty show from 8:30 A.M. to 3:30 P.M.

We arranged entries into three main classes: Puppies, Adult Bitches, and Adult Dogs, and we started with the puppies. The idea is that you muzzle your dog, put him (or her) in the rear of the starting box and walk round to the front. You then attract their attention through the wire covered gate and proceed to run down the track yourself. Your dog then sees you running away from him and in theory will either chase after you or the lure.

Unfortunately, the timing on the first heat was way off and the puppies shot out of the starting box and came to a full stop three yards from the start. This was considered a false start and we decided to run the heat again, and by a process of elimination, cajoling, and by almost chasing one puppy, we managed to get ZUKI across the line as the winner of the Puppy Class.

By the time the females were muzzled and in the starting boxes, the helpers were beginning to get warmed up and were also getting their timing better. The main problem was getting the fur lure timed just a fraction before the gate was opened. As we started to race the adult females, we were in the swing. The winner of this class was Diane Vieira's CH. XALMES BEATRICE.

We all know that a Basenji's tail should be tightly curled, but when running flat out, the tail straightens out, giving a very low, sleek look, with ears flat to the head. When racing, a Basenji looks completely different from his normal

The winners male was our own CH. SOLOYAMBA OF NIANGARA. Some of you may remember his win last year, and so at the present time, he remains undefeated.

One part of the racing that didn't get off the ground was the challenge that was given by a Greyhoundowner. After the write-up of last year's racing, a Greyhound breeder publicly challenged our SOLO to a match race. We wrote accepting the challenge and we agreed to the time and place, but unfortunately they didn't turn up. Maybe they saw a Basenji running in their

Although I do not advocate the breeding of a racing strain of Basenjis and getting into racing on a professional standpoint, I feel sure that we all enjoyed ourselves on October 12th and that the dogs had a really good run!

# BASENJIS IN FRANCE

by Mavis-Barbara Rundle Domaine d'Alverne, 06 Berre-les-Alpes, France

The 'Club International Du Basenji - France' was formed in August and its statutes registered officially with the Prefecture according to French law. It is possible, however, that the new club, the only one so far as is known on the continent of Europe devoted entirely to the Basenji, will have to change its name in order to conform with the requirements of the Societe Centrale Canine (French Kennel Club). The committee has put forward its views concerning the original choice of a name with a truly international flavour, stressing the modern use of the word, "international" in a world which is seemingly growing smaller with fewer and fewer frontiers. France, being the central European country would seem once again to be privileged in becoming the focal point where all can meet, but 'Centrale' has yet to be persuaded of this farseeing view. But, whatever the outcome, the facts and structure of the club remains unaltered and continues to attract interest and new members from many countries, including the United States, which has at the time of writing, four founder members among the first fifty sought. In order, however, that the club may eventually become affiliated with the Societe Centrale Canine (and this is its wish), it has to have fifty members resident in France which will extend the list to approximately double, I should say.

Although myself a resident of France over a number of years, I may not by law have a seat on the committee. The club being French, may only be governed by a body of French citizens. The statutes state that this body may not surpass seven members and it is made up of a president, two vicepresidents, secretary, treasurer and members. They stipulate that an A.G.M. must be held once a year with as many sub-

sequent committee meetings as may be deemed necessary. There is no such thing as a chairman in France so there is no casting vote. For this reason an odd number of members is chosen; five being too few and nine too many in the first stages.


Since, as yet, there are so few Basenji owners in France (there are about 24 registered, 17 of which are my own), the committee has been formed with the kind cooperation of animal lovers in general. One, the vice-president is the 'directirce' of a large 'Refuge' at Draguignan, near St. Tropez, and the other is a barrister who has offered his legal services, gratis, should ever they be needed. The president, Madame Maria Duval, is the only Basenji owner on the committee at the present time. She owns a very nice son and daughter of CH. TAUNY SIMBA, but there are two places as yet unfilled and it is hoped will go eventaully to other owners. I read with interest the article in your November issue of "The Basenji" by Janet Brooks, entitled "Excerpts From Books."

"A series of autopsies were performed on Basenjis to ascertain why the Basenji is barkless; and the researchers came up with the announcement that the Basenji possesses a normal canine larynx and could bark if he wanted to."

In my new book entitled, "Basenji-Dog from the Past," which I hope to have published in 1970, I submit proof in the form of documented evidence as to why the Basenji does not bark, and this evidence will show that this breed <u>cannot</u> bark due to a physiological difference.

Also included in my new book, will be final proof on the Anubis - Dog - Basenji connection and will have documented backing by one of the world's leading Egyptologists, along with information regarding just how long the breed has been barkless.

We always enjoy the fine work you are doing with your magazine.

In answer to the letter from Julian Herzfeld in the November issue regarding his 18-month old problem chewer, a brief summary from William Koehler's (pronounced "Keeler") book, "Koehler Method of Dog Training" follows. First let me state that I have just finished training my two Basenji bitches by the Koehler method of obedience and would like to recommend that any Basenji owner who gets the opportunity to use this method to take advantage of a fantastic opportunity. You actually can train your dog to heel off leash in only ten weeks, and you can lick a lot of problems you may have at the same time. The very first day you work with your dog by this method, he will be following you around and paying attention to you, instead of the usual reverse situation.

Because of my experience with this method, I sincerely believe that anything he recommends will work. In regard to chewing, you can read the section entitled, "Destructive Chewing," on page 183. In summary, he says that a dog with a severe chewing problem probably has a dietary deficiency which causes him to be nervous, restless and noisy in addition to his chewing problem. Organically combined minerals such as are found in sea kelp should be fed to the dog and a change in personality should be noticed in about two weeks. (This does not include the usual vitamin and mineral tablets, it must be organic).

Quoting from the book - "The humaneness and common sense of assuring that a dog has no mineral deficiencies before punishing him for acts that could be caused by such shortages, needs no further justification. When this consideration has been met you can use the following corrective technique without inhibition."

"The specific technique is to select a piece of the material he has chewed, and place it well back, crossways, in his mouth. Use a strip of adhesive tape to wrap the muzzle securely in front of the chewed material, so that no amount of gagging and clawing can force it from his mouth."

"Perhaps you are wondering if these frantic efforts to rid himself of the material will cause the dog to scratch himself painfully. Yes, they surely will, and the person who earned the money that bought the ruined shoe, or the long-awaited piece of furniture, now badly mauled, probably experienced a bit of pain when he surveyed the damage. And if your doggie didn't know any better, he'll know better after an hour or so of his mouth burden. When the tape is finally removed (a bit of ether will remove it easily) you may find he seems to hate the sight of the object. Don't be fooled into thinking he's cured. His recent experience may be just a temporary influence. You want a permanent impression. You can work toward that permanent impression by repeating the "taping in" process the next day, even if he hasn't chewed anything in the meantime. Naturally, if he does chew before the next day, you should immediately tape the last chewed object in his mouth."

"Surveys made in obedience classes to check the effectiveness of this revulsion method show that if the handler will follow through with the taping-in for at least six days after the dog has apparently stopped chewing, eighty percent of these destructive chewers can be reformed."

"Don't take a couple of days without a chewing episode as a sign that your dog doesn't need the clincher of the full six follow-up days. The stronger the 'bad taste' you leave in his mouth the more chance of a permanent impression."

If you think the above quoted method is cruel to the dog, I will give a few more quotes from the book. "A dog has the right to the consequences of his own action." . . . "viciously resentful, problem dogs, since they are bred and influenced by man, have a moral right to the training that may be necessary to rehabilitate them." Most people say they . . . "would prefer proper discipline rather than another more drastic alternative, such as being 'put to sleep.""

# Thoughts Provokin'

ON DISCRIMINATION

As dog owners, we are all aware that we must provide certain protection from disease, etc., for our animals. This includes immunizations periodically for distemper, hepatitis, leptospirosis and rabies. We want this protection for our dogs but in addition, local laws usually require that we must give our dogs rabies vaccinations regularly. There are also dog tags and a fee for them. And perhaps, depending upon the local ordinances, a kennel license even if we do not operate a commercial boarding kennel. And then there are the local "leash laws" which say that our dogs must not roam free and that they must appear on lead unless they are confined in our cars or fenced in our yards. Then you are also responsible for any "vicious" dog you might have - even if the dog was the result of neighbor children poking at it with sticks! (Don't seem surprised - this has actually happened and the people were made to part with the animal even though the dog was merely acting in self-defense.)

As you can see, we not only pay for the dog when we buy him (or for the stud fee if we've bred him) but we regularly pay for his food, housing, health, and any other maintenance. I think we'd all agree that this is quite normal and to be expected and that we really don't object to all of that. If we did, we could rid ourselves of the dog and end the entire matter.

But there is something else that I doubt if most of us have really considered. And in the world of today where many voices are crying out in the land that word "discrimination," I wonder if we shouldn't pause and think a bit. We are required -by laws - to obtain and pay for certain immunizations and we are further required - again by those laws - to license our dogs (in some localities they are more honest and call this a dog tax) and to exercise them on the public by-ways only on

But what of cats? Or monkeys? Or birds? Or any other type of pet? When was the last time you saw a cat on a lead? Or one with a "cat tag?" Or a bird with a rabies tag? Does the last one strike you as ridiculous? It is, and so are those same laws that discriminate against the dog. We'd all prefer to prevent rabies than to have to go through the painful experience of the series of shots that are required when one is bitten by a rabid animal.

Yet the justification for many of the other discriminatory laws is that the dog is a nuisance and has "dirty" habits. Strange, I've always found that I've had the greenest lawn in the neighborhood and haven't lost any shrubbery from the dog's "dirty" habits. I have lost one or two limbs from bushes from one or more dogs running past them too frequently and breaking them off and have even had one or two dogs chew them off.

In the meantime, what of our "friend," the cat? No tag, no rabies shot, no lead and allowed to roam at will. Have you ever been in a cattery? I have, and the stench is one that a friend described as "enough to gag a maggot." It is really unbelieveable! Yet this is allowed to exist and the cats allowed to "make deposits" anywhere. Ever seen what a cat can do to a tree when trying to keep his claws in trim? And have you ever notice the scarcity of birds when a cat is about? And isn't it cute how they "toy" with mice they have caught? Or would you be honest and say "sadistic" rather than cute?

Why should an estimated 20 million cats be allowed a tax-free existence when a like number of dogs are required to donate to the coffers of local governments. Isn't this the basest form of discrimination? Think about it for a minute! You pay taxes for your pets, but others don't. Do you really think this is fair?

You can help to overcome this discriminatory practice by writing your mayor and your city councilmen. Write your county officials and your state representatives and senators. Let them know that you are displeased with the current state of affairs and ask them when they are going to assure fair play for dog owners. Don't be afraid to take action.

One point of information that might be of interest is the following: some years back a friend, seeking trophy donations for his local club, asked a large super market chain for a donation. He was told, "Oh, you people are always asking for something." Said friend then started to leave with a "Thank you for your time," when he was stopped at the VIP'S office door with a "Just a minute." The chap went back and the VIP asked him if he knew what the second largest selling item in the store was. Seems it was dog food! Second only to dairy products. Next time you are in your local super market, check the space they allow for dog food. Do you think they'd allow that much space if it didn't pay off? Let's face it, this is a multi-million dollar business and there is power in numbers.

Unite and write. Let that be our slogan. Stamp out these discriminatory laws which penalize the dog owner. Campaign for our canines! Act!!

paratively new innovation in France and voluntary help of any kind is difficult to get from a hard-working population whose leisure hours are considerably fewer than those in the United States or the United Kingdom, for example.

# BASENJI CLUB OF NEW ENGLAND yankee doin's

"Train your Basenji before entering a point show for better results and more wins!"

We have all heard these words before, and most dogs are trained to some extent before entering the ring. But most dogs have the minimum amount of training necessary to be shown.

It gives one a certain pride and pleasure to sit at ringside and watch a well trained Basenji perform on a loose lead and be interested only in his handler. Put yourself in the judge's shoes - you have two dogs of equal quality - one is well trained and will stand for examination and moves well on a loose lead, and the other dog must be held for examination and is gaited on a tight lead to keep his head off the ground. Which dog would you give the points? The better trained dog, of course - which leads to the question: how can one train a Basenji to show well?

Put a collar on your Basenji when he is about three months old and in a few days he will get used to it. At this time attach a leash to his collar. If he is a normal Basenji, he will feel he must go in absolutely the opposite direction you want him to go, so follow him and in a few days he will get the message and will be walking along where you want to go. Don't overdo it, work with him five to ten minutes each day. Plan on taking a daily walk with your dog on leash and in a few weeks he will associate the leash with the daily walk and will look

At this time your dog is ready to be introduced to a show lead or training choke chain. The first thing a dog should learn on a show lead is to walk at your left side at the speed you want to walk. Give the command, "Heel!" when you start and keep repeating the word, "Heel" while walking. Each command should be spoken firmly so the dog understands you mean business.

When you stop give the command, "Stay" and make your dog stop. Repeat these commands over and over again, and in about three weeks your dog will master these commands.

This type of training should take place on a surface other than grass because Basenjis love to sniff, and you'll have the problem of your dog walking with his head down.

The show lead should be used for training or showing only and a regular collar and leash for daily walks. The dog will soon realize when he has the show lead on, it means work.

The next lesson he must learn is to pose and stand for examination. Posing or setting up your dog is rather easy now because he understands the "stay" command, but standing for examination by a stranger is more difficult. Most young Basenjis can't seem to understand why some stranger would be interested in looking at their teeth or checking their testicles.

The best way to train your dog is to repeat the examination over and over again yourself until he accepts it, and have your friends examine him whenever possible. It is a good idea to take your dog to public places so he won't shy of noise or strangers.

Your dog should now be ready for dog matches or a formal training class (I have permission to show-train mine at a local obedience class).

The best advice one could give is: 'Don't lose your patience, give your dog abundant praise when he performs well and always remember how difficult it would be for us humans to learn if we could neither speak nor write.

I have written this article as brief as possible and will be happy to discuss it futher if anyone is interested.

" From every indication, we will know in the next few weeks just what we will do in regards to this assignment.

You ask, "How are we treated?" - Like Americans in an anti-American country! It is interesting to witness how effortlessly and efficiently the propaganda makers have been able to swing a basically friendly people to complete hatred. I know from many angles this sounds impossible, but believe me, it isn't! The radios, newspapers and television station have fed the Libyan people a steady diet of "Anti" ever since the coup the first of September. Many of these things I would not care to relate to you here and now as they are too grotesque. Perhaps it would be sufficient to say stoning and being spit on is very common-place these days. We are left wondering just what or who will be chosen as the poor "fall guy" when the Americans leave Wheelus!

We did get to Sabratha and to Leptis Magna and managed to get some very lovely slides of both, as well as many of Tripoli. This may seem like such a small thing but its monumental if you will consider that photographs and any fact similar are forbidden now. Even household goods are being searched for these items and are destroyed. Never fear-we found a way to get ours out of the country for safe keeping! "Where there's a will, there's a way!"

The Libyans have taken over the possession of the Post Office Gates, and the MAC (Military Air Craft) terminal. These measures were taken after a couple of international incidents! One is referred to as "The Box Caper" which involved the principal of dependent schools here at Wheelus for smuggling out a man in an instrument box! The other involved some guns belonging to an Air Force man which were being shipped stateside via the docks. The guns had a trade mark on the butt end of - of all things - a six sided star! So immediately, they were branded as being Jewish. A very minor thing but it's just such things that make news these days.

Many, many Libyans are pro-Western. Indeed, the Libyan Air Force could be called pro-Western. Without exception, we have found these men to be above reproach in their attitude towards the Americans on Wheelus. We share this base's facilities and the Americans have trained the Libyan Air Force. They are flying American planes and it takes American aid to keep those planes in the air. Many of the Libyan workers here on Wheelus, fondly called "Sedeeks" which means "friend," have worked here for umpteen years and they are worried about their welfare when we leave. No, all Libyans aren't anti-American. However, their voices have been stilled. Tragic, but true.

I hope one day to be able to write something worthwhile about our Libyan experiences without censorship of any kind. Until then, however, "Don't forget the Alamo!"

May the wind always be at your back!



# GOD HAD A DOG

by Janet Brooks, 10676 Creek Road, Ojai, California 93023

Under the chapter entitled, The Dog in Religion, with the sub-title, Dog Gods, Dog Cults, Dog Worship, page 167 is found this interesting information:

The Nyanga hunting dog personifies the mythological dog RUKUBA, culture hero, fire bringer, and deviser of the dog bell, but he is not deified. The wonderful hunting dogs of the Nyangas are regarded as equal, if not superior to man and have equal rights with the hunters. Each one is dedicated to one of certain nineteen gods or spirits and is the center of a whole complex (social, economic, and religious) of prescriptions, taboos, divinations, blessings, and curses, and the rites de passage of his own life cycle. Formal ritual accompanies the birth of a pup, his initiation into the hunting group, his first game caught, his consecration to a god or spirit, his naming, and his death. He is also regarded as liaison between the living and the dead and is "the symbol of piety toward the ancestors."

To the dog's master a whole ceremonial code and series of observances are obligatory: ritual ablutions for dog, master, family and group; therapeutic and magical practices for health and luck; strict adherence to all prescriptions and taboos; ritual feeding of the dog, sometimes other dogs and sometimes members of the hunting group also; the acquisition of blessings for both dog and master accompanied by invocations and offerings to the spirits.

Every Nyanga man who owns a hunting dog is more concerned with its welfare than with his own. He does his utmost to protect it from wounds, bites, stings and the curses of man or spirit. And the dog himself is provided with amulets specific against harm and danger and for strength, health, luck, courage, etc.

There are many other details of the Nyanga dog complex,

such as the preparation of a special kennel or little house for the pregnant bitch in which the pups are born. There is the complicated business of the disposal of man's dogs at the time of his death; they are sold according to a special set of rules, not inherited. Good and bad omens involving dogs which occur in dreams comprise another no small part of the whole complex.

Whether or not there are other dog cults in Africa comparable to this of the Nyangas is impossible to say. Monographs such as Biebuyck's remarkable study, "De Hond bij de Nyanga" are practically nonexistent.

A search of the Bibliography gives this information on Biebuyck: D. Biebuyck - "De hond bij de Nyanga, Ritueel en Sociologie, "Academie Royale des Sciences Coloniales, Classe des Sciences morales at politiques, Memoires in -8, ns, vol. 8, Brussels, 1955. For a quick but solid review of this monograph see Robert G. Armstrong's review in AA 59: 918, 919 (1957).

reluctance of Basenjis to part with same. "Dear me, you don't need to worry your head about them growing again. I've been removing dew claws for longer than I care to remember!" (In other words, don't try to tell me my job!) Result - three fourths of ST. ERME LADYBIRD'S pups back for a second visit!

Of course, it is absolutely useless to explain to a vet here that some Basenji bitches are mated as late as 30 days, as was the case with a mating we dealt with last year. You receive a condescending smile as if you had suggested that Basenji males carry the pups around in their pouches like a seahorse.

Noticed in the November 21 issue of "Time" magazine, a very nice photo of a Basenji held by 13-year-old Mark Roosevelt, great-grandson of President Theodore, under "People" section. Pity they didn't identify the breed as apparently the lad has the same independent characteristics as his dog.

When asked by an editor to write a critique of a show, it is hard to refuse, but that is just what I am going to do because, basically, I do not approve of critiques. Providing one writes fairly good things about the dogs all the way through then everything is O. K., but directly one is critical of certain points or attempts to give constructive criticism, then the 'fat is in the fire!' However, I did have a wonderful time both in the United States and Canada and was most interested to see the Basenjis.

By and large in both countries, the height and size were more uniform than we are getting in the United Kingdom. Colour was good in nearly all the reds, but the tan on the tri-colours in most cases was poor, being a sort of cream instead of the brilliant tan that I like to see. Surprisingly enough, I saw a lot of round, light eyes together with rather poor feet. All these faults can be bred out and the latter could be due to not enough road walking. The great joy was to see uniformity and I consider the Basenjis that I saw, and judged, to be of a high standard and look forward to seeing more when my husband and I come over for the Westminster Show and then our tour of the States and Canada later in the year.


