

I too, saw the dog on the Lowell Thomas Special, and hope Mr. Pearlman can find out more about these dogs. I've spent much time looking for pictures of Basenjis (in their native land, if possible) or for other ancient, and possibly related breeds.

I read with interest, Ragna Spears' letter in the May issue. In roaming our local public library, I discovered the book, "Animals of East Africa," by Louis S. B. Leakey, and on pages 90 - 91, found the picture of Basenjis that she mentions. It shows four or five flashy red and white Basenjis, holding an antelope-type creature called a "Bongo" at bay while the native hunters emerge from the jungle into the clearing. This is not a photo, however, but a print of a painting. I can't recall the artist's name. I continue to look for authentic pictures, but haven't found very many.

Since I'm finally writing to you, I must also thank you for the wonderful magazine. My husband and I pour through it from cover to cover on the day it arrives. We have a pair of red and white Basenjis, and enjoy comparing their antics with those we read about in "The Basenji." Also, since this is only our second year to show Basenjis, we find many of the articles very helpful and informative. Thank you again!

In your June issue of your good magazine, on page 2 in the "Mailbox," there is an inquiry from a veterinarian regarding changes in the size of Basenji testicles. At age two and one month, and 8 months after siring a litter of five pups, suddenly appeared to have testicles shrunken to about the size of kidney beans! Our vet said he knew that this was rare, but turned up now and then. He provided some capsules of male hormone to be taken one a day. In about four weeks there was a notable increase of dimension. Then we placed our dogs in a boarding kennel and we flew to Europe. When we returned, three weeks later, the testicles had become quite normal, but the hormones were not administered during our absence. There were 6 or 7 capsules left so we asked our veterinarian whether to use them or discard them. He said it seemed proper to use them, so we did. Pretty soon the dog developed a few hard pustules on his neck which had a hard core. After weeks in which these big pimples persisted, they finally dried up. We believe the treatment was successful, but resuming use of the capsules later was a mistake. He seems to be fitted with normal "artillery" now. . . .

The trip referred to was a dandy! We flew first class via TWA direct to Paris, transferred to a plane for Marseille. Paris was blanketed by a snowstorm and Marseille was drowned in rain. But we loved the cozy hotel for 24 hours while waiting to board a grand French cruising ship for two weeks vacation. We had a day at Alicante in Spain on the Mediterranean, a day in Madeira, way out in the Atlantic, then Santa Cruz de Teneriffe (Canary Islands), and a long run down to Dakar in Senegal, Africa, After two days among the blacks with a fantastic black ballet under the baobab trees at night, we sailed back to the Canaries, Las Palmas City. A local troupe of folk dancers in native costume (Spanish) came aboard in the evening to entertain us. Then on to Casablanca in Morocco. During the two days there we went to Rabat, the capital, and visited the

king's palace and the marvelous royal gardens where we had mint tea to drink in a beautiful patio where natives were enjoying Sunday - women with those head-dresses which cover all but their eyes. SECOND ANNUAL BASENJI MATCH

The American Kennel Club did not accept our application for a Plan B-OB Sanctioned Match which we had requested for May 10, 1970. Their letter stated they would need additional information on the individual members as to whether they had registered litters, exhibited, and currently own a Basenji. Since it would take some time to compile this information, and they would want an opportunity to review it, they suggested we go ahead with our plans and schedule it as a Fun Match.

The Club's Second Annual Fun Match was held at Cambria Kennels on Mother's Day, May 10, 1970. Lots of mothers were there - TASSY, TABORA (Basenjis), Carol, Betsy, and Fern (Basenji people), and lots of other BCOSC members and non-members.

What a beautiful day for a match. We were fortunate to have Mr. E. M. Gilbert as our judge. He is a licensed judge. and for the record I would enter under him anytime. He was extremely gentle with our puppies and considered each entry thorougly.

Obedience competition started at 11 A.M., judged by Dee Crandall. Top score of 184 was won by KAZOR'S FARAJI owned and handled by Paul Chen, a new Junior BCOSC member. There were 9 dogs entered in obedience.

Junior member, Laurie Aggas, gave a demonstration of Open Dog Obedience with her Basenji, MACONGO. Dee Crandall directed. The entire scene has been recorded on film. It was heart-warming to see a Basenji trained, but still independent enough to, on recall, take a stroll around the ring looking over all the spectators and continue with the exercise.

Dan Ekern was our auctioneer and the auction brought in a tidy sum. His public address system sure held the match together. Ken Henrichsen is to be complimented on his coordination of the match. Everyone had a job and each and everyone did that job well. I might add that Ken brought tents from San Gabriel Club, so you can thank Ken for the shade.

THE BASENJI STANDARD

(Approved June 8, 1954) Published for the fourth time by popular request.

CHARACTERISTICS -

The Basenji should not bark, but is not mute. The wrinkled forehead and the swift, tireless running gait (resembling a racehorse trotting full out) are typical of the breed.

GENERAL APPEARANCE -

The Basenji is a small, lightly built, short backed dog, giving the impression of being high on the leg compared to its length. The wrinkled head must be proudly carried, and the whole demeanor should be one of poise and alertness.

HEAD AND SKULL -

The skull is flat, well chiseled and of medium width, tapering towards the eyes. The foreface should taper from eye to muzzle and should be shorter than the skull. Muzzle, neither coarse, nor snipy but with rounded cushions. Wrinkles should appear upon the forehead, and be fine and profuse. Side wrinkles are desirable, but should never be exaggerated



into dewlap. Nose - Black greatly desired. A pinkish tinge should not penalize an otherwise first class speciman, but it should be discouraged in breeding. Eyes - Dark hazel, almond shaped, obliquely set and far seeing. Ears - Small, pointed and erect, of fine texture, set well forward on top of head. Mouth - Teeth must be level with scissors bite.

NECK -

Of good length, well crested and slightly full at base of throat. It should be well set into flat, laid back shoulders. Forequarters - The chest should be deep and of medium width. The legs straight with clean fine bone, long forearm and well defined sinews. Pasterns should be of good length, straight and flexible.

BODY -

The body should be short and the back level. The ribs well sprung, with plenty of heart room, deep brisket, short

coupled, and ending in a definite waist. HINDQUARTERS -

Should be strong and muscular, with hocks well let down, turned neither in nor out, with long second thighs.

Small, narrow and compact, with well arched toes.

FEET -



TAIL should be set on top and curled tightly over to either side. COAT -

Short and silky, skin very pliant. COLOR - Chestnut red (the deeper the better) or pure black, or black and tan, all with white feet, chest and tail tip. White legs, white blaze and collar optional.

Bitches 22 pounds approximately. Dogs 24 pounds approximately. Size - Bitches 16 inches and dogs 17 inches from the ground to the top of the shoulder. Bitches 16 inches and dogs 17 inches from the front of the chest to the farthest point of the hindquarters.

FAULTS -

Coarse skull or muzzle. Domed or peaked skull. Dewlap. Round eyes. Low set ears. Overshot or undershot mouths. Wide chest. Wide behind. Heavy bone. Creams shaded or off colors, other than those defined above, should be heavily penalized.

(Pictured is poor head, round eyes, poor feet, low set tail on this cream Basenji.)



Consequently, our show season has practically frozen to a standstill and the first of the Basenji litters are arriving. The schedule for the 1970 Fido National Dog show has arrived. William A. Harvey (U.S.A.) is judging toys and hounds. Frank H. Burch (U. S. A.) non-sporting, sheep and cattle dogs (except German Shepherds), while an Australian, C. E. Milward, is judging gun dogs, terriers and German Shepherds. While reading through the schedule, Jack began laughing, and read the following, "Poodle measuring: The judge must measure all class winners before judging Best of Sex and awarding a Challenge. The measuring will take place in the ring. The judge's decision will be final. First aid service will be available!"

We know some of the Poodle people are a bit touchy about size, but just what is anticipated?

Our friend, Margaret MacKintosh of Victoria, Australia, will not mind my quoting an excerpt from a recent letter:

"Now on to our coursing meeting, held last Sunday. We had a beautiful day, apart from the cold. We had a great rollup and the breeds that came were: 2 Deerhounds, 1 Beagle, Whippets, Afghans, Salukis, 2 Greyhounds, not forgetting our Basenjis. The Whippets, Basenjis and Greyhounds were the only ones that went all the way around. They were started out of the boxes, and is his first race, "BLUE" (MACKINTOSH'S KHAFRE BLUE NILE) went around the wrong way when the boxes opened, but after realizing the others had gone, he soon got going. The Afghans are very cunning - they jumped the track and met the lure half way around. One Afghan jumped the track and went for a swim in the pond. Have you ever seen a wet Afghan? VETERINARY JOURNAL

Recently, a leading veterinarian and lecturer was speaking on the changes that will be evident in companion pet practice in the next decade. The following are some of his predictions, some of which may sound a little far out, but in this age. I wouldn't bet on it.

NEW FACILITIES:

The facilities that will be available for pets will equal those for humans, and hospitals will be staffed with specialists, i.e., orthopedists, ophthalmologists, radiologists, etc.

There will be an increasing emphasis on the training of non-professional people to fill many of the jobs now held by veterinarians, and a licensed nursing profession for veterinary medicine will come into being.

Oral vaccines will replace the injections now being used to protect pets against distemper, hepatitis and rabies. Deworming compounds will be commonly used in the feed and special diets for particular medical conditions are present now, but will gain in use. Surgical procedures to neuter animals will be replaced by injections, and litter size, and determination of sex of the offspring will be possible with a better understanding of sex hormones.

Dog food will continue to grow in sales and the public will come to realize they cannot formulate a ration at home that can equal the nutritious quality of a commercial food. Pet supplies will continue to be one of the fastest growing merchandising areas.

Some of the foregoing may be a little premature, but we are already observing trends in each area that, if continued, will result in the fulfillment of most of these predictions. We are able to double the size of most litters of dogs now with the use of hormones, and as we gain more insight into their use, we should be able to selectively determine the number and perhaps even the sex - who knows?

FIRST HEAT BREEDING:

An age-old question that invariably stirs debate among breeders and dog fanciers is - should a bitch be bred on her first heat. The general consensus is - NO.

But why? No good reason has ever been set forth, and backed up with fact. The prevailing feeling is that the bitch is immature and as such, is not capable of producing the normal,

healthy litter. Another feeling persists that the first litter of any bitch is no good, regardless of the sire or age when bred; again, there is no proof to sustain such a theory.

The bitch, upon going into season the first time, is actually going through puberty and is usually between the ages of 6 and 14 months. Take into consideration the fact that a dog at one year of age is about equivalent to a 20-year-old human and the idea she is too young takes on a new perspective.

Recently, two different reports from England on the effects of breeding dogs on their first heat period appeared in (continued on page 17)

We had the terrible experience recently of losing a dog. Another breeder of our area lost two dogs, so I thought maybe some people would be interested to know what to do in such predicaments. Luckily all three dogs were returned. But after you have searched for hours, you have this helpless feeling of not knowing where to turn. The first thing you think of is the "Lost and Found" ads of the newspapers, but that takes at least one or two days to appear, and every minute the dog is gone increases his chances for injury or death. The most important thing to do is to notify people - all kinds of people. The police and humane society or dog pound. Call the veterinarians in a wide area. One dog in Michigan was found 21 miles from home. Call the radio stations - nearly every locale has a radio station that is civic minded and will put out several bulletins a day for lost pets. Call the dairies. Their drivers cover a lot of territory. Call other breeders. People seeing a purebred dog running loose might call a breeder they know. Call your friends in different parts of town. Most super-markets have bulletins where you can place ads. Make a large sign, using a large picture of your dog on it. This was how one of the dogs was found. You can also go to the neighborhood schools and place a sign on bulletin boards there. Children love treasure hunts. especially if there's a reward offered. Newspaper boys also get around. I hope these suggestions will help others.

BASENJIS IN FRANCE

My husband chauffeured a friend some 800 kilometers to Italy to present, for the first time, two of our 15-month old Basenjis. The result was disastrous! Our beautiful GLOW was sent away with a flea in the ear; dismissed with a MOLTO BUONO accorded to her by the terrier and spaniel judge of the day, Judy De Cassembroot.

The word "sport" is very difficult to apply over here. I hope I will not be misunderstood when I moan a bit about high costs and the absurdity of making efforts such as this when one cannot even be sure of showing one's dogs under the judges advertised. I would emphasise here that the judge advertised in this case - an Italian - was present on the day and was judging hounds! The schedule at the time of making the entries had not been changed and exhibitors were given no reason to suspect that any alterations had been made in Italy, turning the Basenji into a terrier! I will have to await the official report before I can learn details of the judging, because of the language problems, our handler was unable to understand what went wrong.

Neither dog was in full bloom, although I had been working on their coats daily for well over a month, they just would not be forced off before their time. Does anyone have a sure remedy for this problem? I have heard of, and tried out several (all infallible), but none of them has worked so far. I have even included a personal brainwave and taken GLOW to bed with me wondering if the extra warmth and constant caress of the human hand would do the trick, but, no!



DOG HEALTH SEMINAR OF MORRIS ANIMAL FOUNDATION

OPENING REMARKS

It's a pleasure to be given the role of official welcomer of the Morris Animal Foundation - and so, I bid you "welcome" to our first dog health seminar.

When the Morris Animal Foundation was founded in 1948, it was basically a family supported foundation. During the last 22 years it has gradually become a public institution, now being supported by hundreds of public and private contributors. Such an evolution is a testimony to the interest the public has in the health and welfare of its companion animals.

During those 22 years, the Morris Animal Foundation has assisted 160 young scientists in their search for such information about our companion animals. Each of these young men has reported on his work at the Foundation's annual meeting and a copy of that report is on permanent file at the Foundation offices in Denver. Most of these young scientists have contributed writings about their work to the professional literature. Few, however, have had the opportunity to actually interpret their findings in a form that would benefit the companion animal owning public.

The Foundation would be the first to agree that these findings need to be intelligently interpreted and made relevant to the needs of the dog owner. In the past we have excerpted material from the Foundation's annual reports, brought to the attention of the popular press important findings, and from time to time written articles incorporating new information and its application to the dog owner. After all, the Morris Animal Foundation exists, and the work which it sponsors is performed so that your dog can enjoy a better, more healthy life. This can be accomplished only by communicating effectively with the dog owner as well as with the scientist and veterinarian. That is why we are here today, and it is high time we were about the business at hand.

This first seminar on dog health has been put together specifically to interpret research findings for you, the dog owner. There will be time for questions following each presentation. If you do not understand sometning that is said, please speak up at that time.

Unless you leave this afternoon with an improved understanding of the diseases we discuss here, we will not feel that the first seminar on dog health has been successful.



CAPITOL PAW PRINTS

Recent letters from overseas have reminded me that not all countries view the Basenji in the same light that we do here in the United States, in Canada, or in the United Kingdom. Some may place it in the Spitz group or in the terrier group. It was this latter placement that rang the bell. Some of you may remember that some years back this was a suggestion which was being pursued by a number of people in this country, as they felt that the Basenji was a terrier rather than a hound. promarily because it didn't look like a typical hound.

So let's take a look at a "typical" hound. A hound looks like a "houn-dawg," doesn't it? You know what they look like! A hound color (black, tan, and/or white mixture), floppy ears, medium size, rather short coat. You know the type - a hound!

And how do the various breeds of the "Hound" group fit this description? Bassets, Beagles, Bloodhounds, Coonhounds, Foxhounds, and Harriers are all obvious matches for this group and all have somewhat squarish muzzles. Dachshunds might even squeeze in this group for a number of reasons, but what about their rather pointy muzzles and their different structure - including midget-sized legs. And when one thinks of their original function, shouldn't they really be placed in the terrier group? My Dachsie friends scream at this suggestion, although a few do agree.

The next category of similarities would include those of color, ear, and coat specifications to a certain degree, e.g., the Greyhound, the Whippet, and the Saluki. But the Greyhound has great depth of chest where most of the hounds are more "tube-shaped" in body. Muzzles are a bit pointy, and the Whippet's tail even goes the wrong way, being tucked underneath! The Saluki might even squeeze in here too, but what about his long-haired ears (or is he just being "mod?" and he has a very loose-jointed and flexible gait! Squeeze again and try the Scottish Deerhound in here too for his similarity to the Greyhound. only with a shaggy coat, a bit shorter neck, and his tail tucks under more like the Whippet's. The Borzoi also has some similarities to the Greyhound in depth of chest, size, with perhaps a bit shorter neck - but what about that crazy wavy or curly coat? Again a case of going "mod?" And what about the "moddest" of them all, the Afghan Hound. Dig that ca-razy coat on him! With a moustache too and a short-haired saddle on his back - and a spit-curl in the end of his tail!

Of medium size? Certainly not the Irish Wolfhound. His muzzle appears just a bit more long and square than most in the group and his ears are a bit different. I guess he has to be on the large size for his original role. Can't you imagine one coming up to you and asking, "Which way did all the wolves go?" or perhaps, "Pardon me, but did you just see a wolf go by here - fast?"

Then we come to the perfect example of the "hound type," the Norwegian Elkhound! Erect ears, curled tail, long coat, short back and all. His little buddy, the Basenji, simply went to a different barber and had a crew-cut. And perhaps a dye job while he was there!

Let's top this all off with those Greek masks, Comedy and Tragedy - the Otter Hound and the Rhodesian Ridgeback. The Otter Hound looks like a stand-in for "TRAMP" in the TV series "My Three Sons," and appears to be a pleasant, somewhat dull, and very friendly neighbor (except to the Otter). Not so the Ridgeback - running afoul of him could certainly be a tragedy! Hardly seems to be the fun-loving type.

So there we have the true, "typical" hound. In case you've missed it, here's the instant replay. The color is black, tan, and/or white (or some other color). The ears are drop, semi-prick, prick, or folded. The size is medium - somewhere between 8 pounds and 120 pounds. The legs are either short, medium, or long-likewise the body and the mixture of legs and bodies includes almost all permutations. And it has a short, medium, or long coat of fine, coarse, silky, hard, rough, wiry, flat, wavy, curly, firm, soft texture; while the tail must be either gay, curled at the end, tightly curled over the back, carried at the trail, or tucked between the legs. The body must have a deep chest - or be tube shaped - or?

So you see it is all really very simple when we carefully analyze the matter. Now we all know what a "typical hound" looks like and can readily identify its type at any time,

literature. In the first reports, a Beagle colony of 1,500 animals were routinely bred on the average of 278 days of age, roughly 9 months of age. 
THE REALIZATION OF A DREAM

It seems much longer ago than 1965 when I sent two black and white puppies to the HORSLEY KENNELS in England, with the hopes of establishing a breeding program that would produce top quality dominant blacks. These puppies, SHEEN OF HORSLEY and SATIN OF HORSLEY, were sired by KHAJAH'S BLACK FULA CHALLENGE, and out of our BLACK DIAMOND OF CRYON, a lovely dominant black and white bitch, who had many admirers in this country, but who was unregisterable herself because half of her ancestry was African bred. SHEEN OF HORSLEY, bred to the famous ENG. CH. RIDINGSGOLD FANTASIA, produced the equally famous RIDINGSGOLD SIR BUNTAR OF HORSLEY, who later became DATAR'S grandsire. And now, back in the land of his great-grandsire, DATAR has achieved another "first" for the breed - the first dominant black and white Basenji to finish his Championship in the United States. This event occurred at the Kanadasaga Kennel Club show, Canadaigua, New York, June 6, 1970, where DATAR went Best of Winners and acquired his fourth major, under Judge Edmund Kauffman, Jr.

DATAR has a fine show record. He was shown a total of 14 times and finished with 16 points, 4 majors, and a Reserve Winners at the Southern Specialty. His majors were won under Judges: Marsh, Murr, Griggs, and Kauffman.

Our thanks go to the judges who recognized the quality of this young dog, to Dr. Leon and Marie Standifer, from whom I obtained BLACK DIAMOND, and to Mrs. Jayne Stringer, who carried on the breeding program in England.
