

a 26-foot trailer and expect to travel for the next year or so, so will have no place to have anything sent but first class mail. We have been gone since November 1st, and will soon leave again. We took three dogs with us and went to Mexico for the winter. Had a wonderful time and no trouble with the dogs. We did have some trouble getting food. . . We had to feed them tortillas and yellow tail for over a week before we got a veterinary supply to sell us some dog food. They only had it in such large amounts we had no room for it. Finally we found some at the main mill in Ciud Obregon. At any rate, we bought what we could and they ate it although they did not like it as well as the American formula. They seemed to thrive on it although it looked more like a mixture of cereals.

The dogs caused a lot of comment and in one town we parked across from the Catholic school while Russ went after mail, and the Sisters let the boys out and they all came over to see the barkless dogs. I could hear the Sisters telling the boys all about them. While I speak almost no Spanish, I understand enough to know that they were telling about Africa, barkless, history, etc. It was quite a thing to see!

. . . Got all the dogs shots in Phoenix for Arizona health certificates and then to the Mexican counsel for their little visas. It's funny, after all that, we were never once asked if we had the correct papers until we re-entered the United States and were asked about Rabies certificates. If we had not all the required papers we might have been in trouble. One thing - living in Morro Bay, it's quite cold and foggy and when we got into Mexico it was very warm and the dogs began to shed and you never saw more ragged Basenjis. We did buy bottled water for them, so we did not have to change water so often and figured it was safer. We left the trailer in Guaymas at San Carlos Casa Moviles and took one trip just with the car. Had no trouble getting the dogs into the very best motels and hotels, with one exception - we stopped in Tepic. Russ told them we had pets and that was fine. When they saw him walk three, the manager (a woman) came and said, "One pet, yes three, no." And she meant, "No!"

I would appreciate it if you would ask the readers of your magazine if they know of any observed seasonal change in testicular size and function in Basenji dogs. I have heard that this is not unusual, but would like some facts to substantiate it.

Having read in the February issue, Wilma Bauer's comments on her 'show quality' tri bitch which failed to make 16 inches, I can only say the problem works both ways. I own a red and white male which was also sold to me as show quality, and like the Bauer's dog, he has matured with no major faults. Have been told by a professional handler and several experienced members of the local breed club that he is finishable, but also that he may be put down because of a size problem. He stands 17 1/2 inches at one year and weighs 30 pounds in show condition. . . .

In Veronica Tudor-Williams' book, she describes a prize bitch, AMATANGAZIG as only 14 1/2 inches, also other foundation stock as being near that size, while several others are described as large. Thus the Basenji has a mixture of large and small in its family tree, and we Westerners have been breeding these animals only about 30 years. I suspect in Africa, size was not a prime consideration in breeding.

I would say that you cannot be sure that another puppy will not fall short, or perhaps even grow larger than the standard calls for, but if you are going to purchase a puppy rather than an adult, expensive or not, that is the chance which has to be taken. From reading other breed magazines, I see that no breed can absolutely say a puppy will reach standard size at maturity.

If I may also point out the standard would like a **tight** (continued on next page)

MIDWEST FROLICS

Finally spring has sprung in Indiana and the Midwest. The trees are starting to bud, tulips are blooming and the robins are back. Old man winter certainly hated to let go. On consecutive Thursdays prior to the International show, we had two of the worst snowstorms of the season, piling up ten inches of snow each time. It was a good thing that the temperature wasn't too low which helped the road crews clear the highways quickly, making it possible to get to Chicago on Saturday for the International Dog Show on April 4th and 5th.

There were 3,647 dogs entered, making this the largest dog show in the country and the largest entry ever to be recorded for this show. Despite this, the Basenji entry was very disappointing - only 61 Basenjis: 20 dogs, 21 bitches and 20 specials. This is the first time since we have been going to the International show that there hasn't been a five-point major.

The Basenji Club of America supported the Basenji entry at this show, offering silver medallions for each first place winner. The International Kennel Club offered money prizes and the members and friends of The Greater Chicagoland Basenji Club, Incorporated, presented a beautiful trophy display. There were rosettes and silver brandy snifters for all first place winners, chrome napkin holders for the second placers in some of the classes, and chrome and glass chip and dip sets for other class second placers. Chrome trivets for third place winners and chrome and glass dessert dishes for all fourth place winners. Also, there were silver-plated salad bowls for the reserve winners. A silver-plated square vegetable dish for winners dog, a copper engraved Basenji head study ash tray for winners bitch, a silver-plated deep fruit bowl for best of winners, a walnut trophy for best of opposite sex, and a silver-plated, three-piece coffee, tea service on an engraved tray for best of breed.

Best of Breed was won by CH. LULAROY'S CARMINE ROYALE, owned by Ralph J. Shcuirmann. CARMINE ROYALE is a grandson of ENG, and AM, CH, ANDERSLEY ATLANTIC in whose honor the trophy was given. KETKET'S FUZZY FAITH went all the way to Best of Winners and Best of Opposite Sex from the Bred-by-Exhibitor class. Tom and Ann Diener are her breeders. Winners Dog was CAMBRIA'S KAROO, Karin M. Mainzinger, owner.

There were also three Basenii braces. The winners were DONBAR'S TONI RONI and DONBAR'S HONEY BEAR, owned by Barbara and Donald H. Burr of Des Moines, Iowa. Only one Basenji was entered in obedience. Mrs. Cornelius Clem of Indianapolis showed CARLO OF BLUE CLOUD, CDX in Utility Class. Mrs. Clem said she thought CARLO was the only Basenji in the country doing utility work now.

A two-day benched show, such as the International is very tiring for exhibitors and dogs, but it is a wonderful opportunity to show off our breed. Thousands of people pass the benches and ask questions about the breed. The comment we heard more often than I like to think about was, "I've heard Basenjis are vicious!" Or, "I have a Basenji and he's mean." Even at ringside when the groups were judged, one man behind us said, "Oh, they're vicious, they can't be trusted around children at all." The sad part about this is that a lot of this is true. There are too many dogs and bitches being shown and used for breeding with bad temperaments. A lot of times a young and inexperienced dog can be made to appear vicious when actually the problem stems from lack of proper socialization and training before the show. The puppy leads a quiet, secluded life, seeing only his family and their friends - then suddenly comes the day for his first show. With no advanced (continued on next page)

preparation he is thrust into an entirely different atmosphere. With all the noise, strange dogs, strange people, he becomes thoroughly confused and frightened. As a result he cowers, growls and snaps, and people say there is another vicious Basenji. Taking him to puppy matches and out in public at a very young age will overcome this. But there is the case of an older dog who has been properly socialized, properly prepared and still shows signs of shyness or over aggressiveness. This is inherited bad temperament and this dog should never be used for breeding or be shown, no matter how fine a physical specimen. I know that other breeds have this problem too, but our concern is for our own breed. In order to improve the image, we must eliminate the cause. Temperament should be the first consideration of any breeding program.

RECENT SHOWS IN GREAT BRITAIN

Pride of place in the British show calendar goes, of course, to Crufts held at Olympia in London during February. This is because of its size and traditions. It takes its name from the fact that before being taken over by the Kennel Club, it was a commercial enterprise run by the famous Charles Cruft. In spite of entry restrictions recently introduced, requiring all exhibits to have won certain awards previously, this year's entry was 14,425, made by 8,398 dogs. (This week's dog press, however, reveals that the forthcoming show of the West of England Ladies' Kennel Association, has drawn an entry, a world record, of no less than 8,604 dogs). Top prizes at Crufts were awarded by H. R. H. Princess Margaretha of Sweden.

The Basenji entry was 100 made by 50 exhibits, giving an average entry per class of 12.5. The judge was Mr. Joe Braddon, one of our best-known all-rounders. The first prize winners were as follows:

Junior (15 entries) Rakowski's PEREGRINE OF TAL-SUS, 15 months, red and white dog. Also won Reserve C.C.

Novice (14 entries) Butterworth's SONGBIRD OF OR-LANDOS, red and white bitch.

Graduate Dog (13 entries) PEREGRINE OF TALSUS. Limit Dog (15 entries) Mason's REDESGARTH DAVIOT, red and white dog.

Open Dog (14 entries) Dog C.C., Graham's CH. AN-TAGA OF COURTLANDS, red and white son of KHAN OF BA-SENLAKE. Gained his third C. C. under me at Birmingham National Show, He is rather smaller than most recent winning dogs, but is beautifully typey, elegant and sound, and one of the best moving dogs about. His wins demonstrate that if a dog is good enough, and is within the limits of size allowed in whichever direction, he can win over here.

Graduate Bitch (13 entries) SONGBIRD OF ORLANDOS. Limit Bitch (9 entries) Bowers' DOMEWOOD PSYCHE.

Open Bitch (7 entries) Bitch C.C. and Best of Breed, Gallagher's CH. ILONA OF MOCHI. Tri bitch, just 7 years old; she gained her title at the previous show after a long run of Reserve C.C.'s. A daughter of CH. ROLPH OF LITTLEBREACH she has lost none of her refinement and her win was a real triumph of persistence by her sporting owner who has kept her in splendid condition.

Second in this class was the Reserve C. C. winner, Stringers' black and white CH, SIRCILLATAR OF HORSLEY.

The next general championship show on our calendar is Manchester, held towards the end of March. The entry of 10,553 was made by 6,619 dogs, giving an overall class entry average of 11.7. The Basenji entry of 81 made by 40 Basenjis was judged by another noted all-rounder, Mr. Herbert Essam. First prize winners were as follows:

Novice (9 entries) Anderson and Watson's PIERROT OF TALSUS, red and white dog.

Yearling (12 entries) PEREGRINE OF TALSUS. Graduate (16 entries) PEREGRINE OF TALSUS.

Limit (16 entries) Ellis's KHAN OF BASENLAKE, tri. Open Dog - C. C. and Best of Breed, Graham's CH.

ANTAGA OF COURTLANDS. Second and Reserve C. C. was Berry's CH. TOPFLIGHT OF SIN.

Open Bitch - C.C., Stringers' CH. SIRCILLATAR OF HORSLEY. Second and Reserve C.C., Bowers' DOMEWOOD

A notable feature of the Basenji scene over here at the moment is the dearth of good tris in the ring. I do not know why this should be as there have been a number of attractive tri champions in the past and I have not noted any strong antitri bias on the part of judges. It has always seemed difficult to produce enough tris with short, sleek, deep black coats so perhaps breeders think it not worth the trouble. Their place certainly seems to have been taken over by the black and whites recently. I think it is a great pity if we can't have a good proportion of both, since a really good tri can look superb in the ring. I remember how smart Mr. Kargol's well-known winning tri dog, CH. LOGRAK LIDO used to look during the late 50's. I would like to see my Best of Winners at Santa Barbara, SHI-KARI'S BLACK MAMBA, competing over here. I am sure he would do very well and make many friends for the tricolours.

BASENJIS IN FRANCE

by Genie Rundle Domaine D'Alverne, 06 Berre-les-Alpes, France

OPERATION S. O. B. (Save Our Basenjis), HELP!

I now have it on the best authority that the Federation Cynologique Internationale (FCI) has indeed decided to classify the Basenji as a Terrier for a period of two years, during which time it will examine the problem on an international basis. I confess that the whole argument, or rather, it's cause remains obscure since, as far as I know throughout the world, in countries affiliated and non-affiliated with the FCI, the Basenji is still judged as a hound. At the time of writing no change has been made in Italy, and if it is, I imagine it will cause considerable astonishment for the majority of hound judges in that country who are now familiar with the breed. It would therefore be absurd to take it out of their hands and place it into others, perhaps totally unacquainted with it. It remains to be seen. As Italy is affiliated with the FCI, it would seem a logical fatality to look forward to with apprehension.

Certainly readers of "The Basenji" are astonished and many have written me very kind letters which they hope may serve some useful purpose. All may rest assured that each one has already been brought to the notice of those most able to help and have been filed away for use at a later date. One dear lady - a well-known expert of long standing - suggested that I might write a thesis on "Terriers versus Hounds," but I do not feel qualified, much as I would appreciate reading what others might have to say on the subject.

I took myself to the book shelves and withdrew a gigantic (and rather dusty) Webster's dictionary - 1928. Looking up "Terrier," I found:- "One of certain breeds of dogs differing much in shape, coat, etc., but generally small, vivacious,

intelligent and courageous. They are good pets and are useful in hunting some kinds of game, for killing rats, etc. Among the principal breeds are the Airdale, Bedlington, Black and Tan, Bull, Dandie Dinmont, Fox, Scottish and Skye Terriers. Imagine a Bedlington expert judging a Basenji."

Turning to "Hounds," I read: - "A dog of any breed, in modern usage, specifically, a dog of any of certain breeds used in the chase. The typical hounds have large, drooping ears, and a deep voice of characteristic tone, and follow their prey by scent. When used without qualification, the term usually. especially in England, designates the Foxhound. Other more or less important and typical breeds are the Harrier. Bloodhound, Otter Hound, etc. (see these terms also, Boar Hound and Staghound.) Also, any of various other breeds of hunting dogs which follow their prey chiefly or entirely by sight, as the Greyhound, Scotch Deerhound and the Wolfhound. - (still quoting): 2. A despicable person. 'Boy, false hound.' Shak." In other words, a Basenji. (See article in December 1969 issue: The Balikwekwe.)

There is, however, a point more serious which has struck me as being in favour of the Basenji as a hound rather than a terrier. From lifelong experience with dogs, and with apologies to all terrier owners - terriers, as a whole are a very noisy lot, rather aggressive and unsociable. In other words, they bark a lot. Hounds, on the other hand (let's not think of them in an organized hunting pack), are much more passive, more gentle and sweetly sociable. Isn't that our Basenji too?

A series of thoughts then come to my mind which should please A. B. Reeder of the "Thoughts Provokin" column, and that is - according to the FCI, there are two distinct varieties of Basenjis; those from the plains and those from the woodland areas - or forest. The dogs from the plains are stated to be "about 40 centimeters in height, strongly built, light red colour with large white shirt fronts, extending into a large white collar and standing high on the leg which is white." The other type, called "woodland variety," is smaller and better adapted by its size to its natural environment, darker red, almost mahogany in colour; very pegmented and with considerably less white.

Let us stop for a second and think about all this, remembering that the FCI has its headquarters in Belgium and that Congo was once part of that country. Whence came the name, "Congo Terrier?" From the Belgians themselves or from some other misguided traveler who was understandably

mystified by this strange but so appealing discovery, now known as the Basenji. But what's in a name - so relatively unimportant

There are therefore, apparently, two distinct types of Basenjis, and I must admit that I believe it is possible. What is so difficult here, however, is that the FCI maintains it follows and upholds the standard laid down by the Basenji Club of Great Britain in 1939 and later revised in 1942, and yet the British standard makes no mention of any such two varieties. To take the point even further, and thinking in terms of size, it has often been suggested that like other breeds, the Basenji might be divided into two or three categories - standard, miniature and toy, yet the knowledgable, expert breeder will cringe in horror at the very thought. So exactly where are we? Are we just going to sit back and say it doesn't matter? Do we care or don't we? If we do then we've got to do something and not just snuggle in an armchair reading this magazine hoping someone else will labour the cause for us. I am unconvinced at the present about any particular view, and with an open mind that it is possible that there are two separate types being bred today which, if they were interbred, would give rise to the problems which beset the breed now, mainly perhaps because of size and colour. The spectator at a show might well be puzzled by the divergencies of the type seen in the ring. If owners and breeders could be persuaded to accept this theory, a large part of the problem would already be solved. What is just as worrying seems to be the question of not only whether the Basenji is a Terrier or a Hound, but also which type is the correct one. The tendency seems to be for the potential pet owner to prefer the 'less correct type' to that which the expert will consider a near perfect example. To elaborate on this would run into volumes so I am hoping we all know what I am trying to explain and distinguish one from the other. Briefly, I

would suggest that ears and length of muzzle paly a large part in producing this difference.

But - and here is another problem! Who is going to decide all this for us? Can we leave the decision to the FCI just because it doesn't seem to concern those of us who are not affiliated with it? Or could we (I say "we" without knowing who), set up an International body of experts who could get together with the FCI and bring about a formal unity of opinion. I believe it is possible but we have no time to lose.

As I see it, the Federation is not as entirely international as its name suggests, otherwise all countries would already belong, whereas, in fact, many kennel clubs remain independent and outside its direction. How to unite these authorities? There must surely be a means which would be universally acceptable?

Let's face facts - this is not a personal problem any more. It has gone far beyond that and our own small club here in France. It has become a truly universal problem because the FCI is to make its investigation and pronounce its verdict only after having consulted other countries. I do not think it intends to confine itself merely to countries which are affiliated with it for this would solve nothing. The majority of Basenjis throughout the world exist and accumulate in numbers and popularity in countries which are outside the Federation, and they must make themselves heard!

I suppose it would be pretty useless to suggest collecting petitions from these independent countries since the FCI is a power of its own with its own authority and internal functions. but I feel it would not be a waste of time to send our personal views direct to the FCI. If, during the next two years an international committee of Basenji owners and breeders could be formed to help sort out all the problems. A private, purely voluntary ballot would be of infinite value for the good of the (continued on next page)

It is clear that everything is to be reviewed, and if the standard is to be studied, then it will almost certainly be revised, but by whom? The problem concerns each one of us and our dogs - his size, colour, conformation - the lot!

As far as the Basenji Club in this country is concerned, it is for the present powerless since it is not in line with the FCI'S new views and it will not allow itself to be swallowed up by the Terriers. Affiliation with the Societe Centrale Canine has therefore also been impossible (see translation of letter below), but this is not too serious or final since the general rule follows that a club has to be established for at least two years before it can be formally recognized. We believe fervently in our mission, and judging by the general sympathy shown, we have the Basenji people who matter backing us up from all sides.

A solution might be reached before the two years are up, and for those who would care to advance the cause, here is where you should wirte: Monsieur Le President, Federation Cynologique Internationale (FCI), Secretariat General, 12 Rue Leopold 11, Thuin, Belgium,

Pour your hearts out in these letters and show them, not only how much we love our breed, but also awaken the minds of those who do not realize how important a Basenji is to us. It is not a breed easy to kick around and neither are we, the owners! Everyone should come forward. I feel that it is a serious enough matter to go beyond the individual. Clubs, associations, societies, everyone should speak up for our Basenjis. Our Basenjis have not taken their rightful place yet in Europe.

LAST MINUTE FLASH!

We acknowledge receipt of your letter of the 25th of March, as well as those of the 7th of January, 23rd of January and the 3rd of February, 1970.

At the meeting held on the 23rd of January, the committee of the Societe Centrale Canine re-examined your request for the affiliation of a Basenji Club, but could only reaffirm its decision of the 3rd of October, which ascertained that the existence of Basenjis in France did not necessitate a special club for the breed. In consequence it is now in your interest to join an association of a different breed.

In our (the letter reads "your" but is presumably an error), letter of the 28th of October, we were waiting for a decision from the FCI concerning the standard in order to know into which category the Basenji should be placed. This is now done and the commission has decided to place it in the third group, that is to say the Terriers.

The Basenji is classed as a hound in the United States. Canada, England and Australia. I respectfully suggest that the Basenji be classed as a hound in France and Italy.





YODELS FROM THE EVERGREEN BASENJI CLUB

The first eight shows of the year are over in the Pacific Northwest. Portland, an easy 3-hour drive for most EBC members; Seattle; Bremerton, and over the waves via ferryboat with Judy Zenner along. Pullman, over the pass and five hours away (if the pass is clear); Spokane the next day, two hours north; then the five or six hour drive home. For those who had to stay late, it took an extra two hours due to a heavy storm of wind and rain in the pass during the early evening. CH. PHEMISTER'S HAPPY DAY won Best of Breed at Pine Bluff, "HAPPY" and his proud owner were on the April 1969 cover. Peggie handled her CH. CAMBRIA'S MIKANDO for the first time and had the thrill of accepting Best of Breed ribbon and trophy at Memphis.

It is increasingly difficult for us to leave home since our son and favorite dog-sitter became a navy man. One of our doggy friends tended the animals. Pat Love is a Schnauzer breeder but is fast becoming very knowledgeable about Basenjis. Pat and daughter, Carla have looked after our dogs previously. There's always an amusing incident to relate upon our return. The dogs dote on them and show their love with ingenious

Speaking of Basenii antics, I heard a good one in Memphis. A friend from Helena, Arkansas, has a Basenji with a penchant for breaking windows, a specific one, to be exact. In the past weeks Almeda has replaced three panes. She says the dog is "smartening up." The first pane required six stitches in his feet; the second, four; the third time not a scratch!

I've had a number of favorable comments on my recent article on pet shops. Since its writing I've conducted some extensive investigations with the assistance of other dog writers and breeders of practices of these establishments. Through the efforts of one of our west coast dog writers and a kennel club in the east, one chain has been dissolved.

It is in the interest of purebred dogs that pet shop sales are discouraged. It is simply impossible for breeders to sell select stock to pet shops for resale. Therefore, pets are sold as representative of a breed and the result is detrimental to the promotion of purebred dogs which is the goal of all sincere breeders. It is not the sales competition which is distressing to those who strive to improve our breed - it is that quality is being sacrificed for quantity.

WHAT IS SPORTSMANSHIP?

THE WORLD of dogs and showing is supposed to be synonymous with the word sportsmanship. But before we can say it is or isn't, or state that we are or are not good sportsmen, we must understand the word. According to Webster's New Collegiate Dictionary, copyright 1953: "sportsmanship. Skill in or devotion to sports; esp., conduct becoming to a sportsman, involving honest rivalry and graceful acceptance of results." And "sportsman. 2. One who in sports is fair and generous, a good loser and a graceful winner."

And where should sportsmanship be found? In all facets of our dog world. In the showing, around the show ring, on show grounds, in after show etiquette, and in advertising - in other words, in every aspect of dogs. But since we are all human, we can at one time or another be guilty of honest mistakes and should not be condemned as poor sportsmen for these instances.

The ring is the most commonly thought of place for good sportsmanship. Each exhibitor is in the ring to win, but to win fairly and honestly as good sportsmen. Some of the things to consider are: not holding up the judge by being late, not cutting in front of another's dog when entering the ring in order to be in front, not crowding the dog in front, not stopping on a dime, checking to see all exhibitors are standing up before starting the round-the-ring gaiting, and leaving the ring quickly and quietly when not awarded a placement and saying a simple "thank you" to the judge as he hands you a ribbon.

Around the ring is also the place for sportsmanship. Carelessly stated comments about: the condition of another's dog, their manner of dress, pre-judging the class for the judge, and about the judge's decisions are uncalled for, and personal opinions and thoughts should not be spoken so others can hear. It is courteous to congratulate each winner, even those who got fourth place, for they worked for that placement. No award is too small to be overlooked. Remember, it takes the losers to make the count for the winners points. But equally good sportsmanship, in our humble opinion, are those people who don't congratulate a winner because they wouldn't mean a word of it, if the words were spoken - hollow and insincere words are unpleasant to hear. And if someone asks a question, answer it courteously, honestly and promptly-don't pretend you didn't hear them.

Good sportsmanship on the show grounds is also part of the sport. If another Basenjite greets you, even casually in passing, it is polite, social courtesy to respond instead of passing them as though they have the plague. A good sportsman doesn't let personal feelings interfere with proper social courtesies. Newcomers to the breed often seek help from those more familiar with showing Basenjis. It shows good sportsmanship to give these people both grooming and handling tips. Stop and think for a moment - aren't you somewhat prouder of a win over a handler than a win

over a non-groomed, poorly handled dog?

At numerous shows, trophies are offered. People have spent time and money getting these lists together. Fine, you win a lovely trophy, and your Basenji deserved to win, but does it stop there? A truly good sportsman would thank the donor, personally or by letter. After all, they didn't have to offer the trophy.

What may seem strange to many is when we mention good sportsmanship in advertising. The definition again: "involving honest rivalry and graceful acceptance of results." Ads should contain facts, truthful facts and not any promises or statements based on possible facts. Too many times these possible facts are proved incorrect. But the "fact" has been spread meanwhile with the "condition clause" oftentimes omitted and possibly a corrected ad never appears to reveal the positive facts. A good sportsman states only items he will back up - he calls "a spade, a spade," and he evaluates his stock without kennel blindness.

Now we come to a particularly "sticky" problem. Show entries close anywhere from two to three weeks prior to the actual show date. An exhibitor has shows in between and does some winning. Here are the problems: a) the dog needs only one major; b) the dog is being handled by a junior in junior handling; c) the dog is on the grounds or on circuit. What does one do? We say it is up to the individual and his conscience. After all, they have paid their entry fee as everyone else and the money isn't refundable. Point by point now: a) consider how many majors are in your area and if your dog will get out of ring practice sitting until the next show (remember also that no one will remark about your showing if you lose, only if you win - are they being good sportsman?) Also consider if you have another to show in the meantime while waiting for the major. And if one show was a major last year doesn't necessarily mean it will be a major this year. Likewise in judges - because one drew a top entry last year doesn't always mean he'll do the same this time. b) A junior can only handle a "family" dog so if it is the only family dog entered, are you going to be a poor sport and criticize the junior when their main interest is in junior handling? c) The rules state that if a dog is on the grounds it must be shown. Numerous times (more and more with each judging schedule) the count in the breeds is incorrect. Are you going to gamble and leave your dog home only to find it is a major once you're there?

So you see there are many facets to good sportsmanship. We have tried to highlight various points - points which reflect on the Basenji and the owner. Search your mind, evaluate yourself honestly, then take hold of your bootstraps and pull yourself into ALL phases of good sportsmanship. Dog showing/breeding is a sport despite the business attitude which some phases demand on the individual.

Canines Played Important Parts in Ancient Myths

Since he has been so closely allied with man through the ages, it is not surprising that dog plays an important part in ancient myth and legend. Many of these legends were wrapped in the nebulous garments of superstition; others have become interesting bits of everlasting folklore.

Perhaps the most widely known myth is that concerning Diana, the virgin goddess of hunting, and the dog of Procris. This dog, according to fifth century tradition, was the progenitor of the Molossian hounds and those of Sparta. Procris was Diana's dearest friend, and the wife of Sephalus. The goddess gave Procris a dog always sure of its prey and a javelin which should never fail of its mark. These presents, Procris gave to her husband. Sephalis was a great lover of hunting and was happy with his wife and treasures.

According to the myth, some angry deity had sent a predatory fox to harass the countryside. Lelaps, the dog, was known to be able to outrun any rival, and so the hunter came to Sephalus and asked to borrow the dog in order to put an end to the fox's depredation.

Set on the fox's trail, Lelaps started off with such great speed that the eye could not follow him. Had it not been for his footsteps in the sand the hunters would have believed that he flew through the air. Try as he would, the fox could not elude him, even though it resorted to every ruse. Hard on the fox's heels came Lelaps, unsuccessfully snapping at the elusive fox. Just as Sephalus was about to hurl his javelin, both fox and dog stopped midstride. The gods, who had endowed them both with speed and ability, were not willing that either should conquer, and turned dog and fox into stone, leaving them in the lifelike attitude of the chase.

The ancient Greeks believed that the dogs could protect them, not only from earthly danger, but also from evil spirits. If a man suspected that he was going insane, he carried a dog with him wherever he went, believing it would keep the evil ones from disturbing his brain.

A legend, said to have originated in India, is to the effect that God made Adam and Eve and during the night a serpent came and devoured them. This made God extremely angry, but he made them again. And again, on the second night the same thing happened. But God was not to be outdone. He re-made Adam and Eve and this time made the dog to protect them. The serpent appeared that night, but was driven away by the dog's ferocious barking. That led to the belief in India that when a dog howls, a man is dying.

Ulysses' Dog Argus

One of the most famous of ancient dog stories is that of Ulysses' dog Argus. Argus spent the days of his youth in happy hunting grounds with Ulysses, but when the latter set forth on his travels, Argus was left behind. About ten years later, Ulysses returned, disguised as a beggar. No one recognized him. However, as he approached the palace, he came upon Argus, weak and crippled with age, with only a dung-heap as his bed. The dog recognized his master's voice and crawled to him. Argus tried to lick the hand of Ulysses, but was too weak to do so, and he sank dead at his master's feet. Ulysses was almost overcome by the loss of the only friend who had not forgotten him.

Another, and very ancient legend concerns the Beginning. It is related that after God created the world and all its animals, he made man as his masterpiece. But, through his own actions, man brought upon himself the wrath of God, who caused a great chasm to open between man and the other beasts. Among these beasts was the dog, which had become very attached to man. As he watched the chasm slowly widen, the dog with a mighty leap cleared the widening gulf landing at the side of man where he has remained ever since as faithful companion, protector, and servant.

Dog's Faithfulness

Many stories have been told about dog's faithfulness to the memory of his master. Among them is one dating back to 250 B.C., during the reign of King Pyrrhus. One of the King's slaves was attacked and slain by two men, who also beat off the efforts of the slave's dog to protect him. The dog remained by the body which was left by the side of the road. King Pyrrhus, passing by, ordered the body to be buried and taking compassion on the faithful dog, took it back to the palace where the dog became his constant companion. One day while the king was reviewing his troops, the dog suddenly rushed out and attacked two soldiers who confessed their crime to escape the animal's fury.

BOOK REVIEW

Titcomb, Margaret. Dog and Man in the Ancient Pacific; With Special Attention to Hawaii. Special publication 59 of the Bernice P. Bishop Museum, Honolulu, Oahu, Hawaii, 1969. 91 pages. \$3.25.

"The dog is straight-haired, small and insignificant looking, has a fox-like head, a flat snout, and blunt, upstanding ears, rounded at the tip usually the color is rust-red, slightly vellowish. The snout is white, also the forehead, throat, belly and tail tip. It is remarkable that the dog does not bark. At Astrolabe Bay I did not hear the usual howling concert, all dogs howling in unison. . . " The time is correct, the mid 1880's, but the location is not central Africa. It is eastern New Guinea. An illustration of women with dogs could easily be mistaken for one from the Congo.

In this all too short, appetite whetting book, the author surveys the primitive dogs of eleven Polynesian islands. The author quotes pertinent sections of the records of the early explorers of the area and describes the various uses made of the dogs - largely culinary!
