

THE COVER STORY

THE ECLIPSER OF WOZ is from an excellent litter by CH. CAMBRIA'S KILIMANJARO x CH. SHAR'S MISCHIEF OF WOZ, C.D. A look at his pedigree will show him to be strongly line-bred to the famous old stud CH. BETTINA'S ORYX through his two Top Winning sons: CH, CAMBRIA'S SHAR and CH, CAMBRIA'S TI-MUNGAI.

This is a tall, well proportioned dog of smooth, clean lines who excels in tight, cat-like feet, strong, straight forelegs, and his long arched neck which is combined with a short, level back. He also has the desired underline with a deep brisket and high tuck-up, as called for by our standard. He has a perfect scissors bite; he has been x-rayed and C. F. A. certified for sound hips; and he has been slit-beam examined and passed as clear-eyed from early puppyhood.

Since he is first and foremost my pet and companion, his most outstanding quality, in my opinion, is his tremendous disposition. He is lively and full of play and he likes people. He is not, however, a destructive dog and so he is a completely trusted house-pet.

CLIPPER and I started out together as newcomers to the show ring, and we have been learning from each other as we go. His first points came from the puppy class in his second show where he won Best of Opposite Sex over a special. He now has 9 points, including a Best of Breed win and another Best of Opposite Sex, all over champions.

To date, he has sired four litters and from the looks of these puppies, we feel he shows great promise as a stud dog. 

ORTHOPEDIC FOUNDATION FOR ANIMALS, INC. OFA DYSPLASIA CONTROL REGISTRY PROCEDURE

It is important for the conscientious breeder to learn all he can possibly know about his breeding stock. The prevalence of hip dysplasia in large working breeds is a very real concern for all dedicated to the breeding of these fine animals. The Dysplasia Control Registry of the Orthopedic Foundation for Animals (OFA) offers breeders and practicing veterinarians expert unbiased evaluation of pelvic radiographs taken for interpretation of the status of the hip joints of mature and young adult animals.

When you have a dog x-rayed by your veterinarian, it is necessary for him to properly position the animal for good film evaluation. For most large dogs this requires a general anesthetic or heavy sedation to prevent motion and to allow for the proper extension of the hind limbs. It is adviseable to make more than one film when the dog is anesthesized for future study and/or reference for comparative purposes. The manner in which additional films are produced depends upon the discretion of the veterinarian making the film.

For submission of radiographs to the OFA, it is necessary to have the film permanently identified at the time the radiograph is taken with the following information: registered

name, AKC registration number, birth date, and owner's name The veterinarian should identify the name of his hospital and the date the film was taken on the radiograph. The age requirement for certification of a pelvic radiograph is one year of age or older since the dog's musculo-skeletal system is nearly mature at this time. For large, fast-growing breeds, an ideal time for taking pelvic films is the period between 18 and 30 months. It is necessary to submit with the radiograph a completed and signed application form, along with a service fee check for \$10. Application forms and mailing envelopes are available from the Orthopedic Foundation for Animals, Inc., 817 Virginia Avenue, Columbia, Missouri 65201.

> When your film is received at the Missouri office, the film is screened as to diagnostic quality and proper positioning. An application number is assigned to each film of satisfactory quality which has a completed and signed application form. Groups of films are then air-mailed to three different veterinary radiologists, all of whom are specialists in diagnostic pelvic radiography and who are qualified specialists in radiology as certified by the American College of Veterinary Radiology. When the first radiologist has completed his evaluation, the films are returned by air-mail to the OFA with his interpretations for each film. The group of films is then sent to the second and third radiologists for their interpretations. None of the radiologists are aware of how the other radiologists evaluated the films until the final report has been sent to the owners to insure unbiased and objective evaluation. A concensus report is issued on the basis of the evaluations of the three radiological interpretations, and if the concensus is normal, a certificate of normalcy is issued to the owner of record and an OFA certificate number is issued for the dog, coded by breed and serial number. In the case of the dyplastic concensus, no certificate is issued and a confidential report is sent only to the owner and referring veterinarian. The case of young dogs with marginal conformation of the hip joints, the radiologists may not be able to evaluate the true status of the hip joints and may request that another pelvic evaluation be made for comparative purposes. This may be an immediate request or an evaluation to be made when the dog has had additional time to mature. This re-evaluation is made without

On reading Joyce Mullis's report on her visit to Miss Veronica Tudor-Williams (appearing in "London Limelights" of the September 1970 issue of "The Basenji") I was so astonished that she did not make any real comments on the slides of the 1959 trip into the Southern Sudan, where the now famous FULA OF THE CONGO was found, that I feel compelled to make good the omission.

When Joyce and her family visited Veronica's home. I was also a guest in her house, and I also saw the coloured slides. We saw shots of the preparation for safari into the Zande country in search of native Basenjis and the eventual finding of some delightful dogs and bitches with their native masters. The slides showed glimpses of the progress of Veronica and her companions from one native village to the next and their disappointment when beautiful, typey specimens were seen but could not be bought, so highly prized were they by their owners. We saw mixed groups of reds, tris and tigerstriped, some fully grown and elegant, and others still puppies. The puppies were nearly always cradled in the arms of their owners; and there were many slides of grown dogs, some against a background of green tropical forest and bush; the reds standing out like captured splashes of sunlight, and the blending into the shadows with the natural grace of animals of the wild. There were several slides of the puppies which were brought back - FULA and the tiger-striped BINZA (full title now-CH. BINZA OF LAUGHING BROOK) and these were quite delightful.

For a time I was transported by the slides to the natural world of the Basenji, and I realised after the showing that I had seen something quite unique in the documentation of the present developement of the breed. Finally we saw some slides of a few "OF THE CONGO" Champions, CH. FULAFUTURE OF THE CONGO being the most outstanding. Miss Veronica Tudor-Williams has, to date, bred 99 Champion Basenjis, and the contribution made by FULA herself to the recent improvement in the breed can best be summed up by Stanley Dangerfield's own words, "Although only nine short years ago, all the world's Top Basenjis are descended from FULA. No dog in any breed has ever made a more dramatic contribution to progress!"

I understand that less than six Americans have been lucky enough to see the slides of the "Fula Safari." One of these was Walter R. Fletcher, Kennel Editor of the 'New York Times," who paid a flying visit to England in 1968 to meet four of the Top British Dog Breeders (his visit was too short to see more than four). Miss Veronica Tudor-Williams was one of the four he chose to visit. After seeing the "Fula Safari" slides his comment was, "Wonderful - Americans would go mad over



CURLY TALES FROM THE ROCKY MOUNTAINS

This month I have worked up a tally of the Top Ten Basenjis in the country in both Best of Breed wins and Group Placements. For any new readers who might not know what is involved, I will briefly explain the system. Of course, the number of Best of Breed wins per dog is self explanatory. Points earned for group placements are determined by the number of hounds a particular Basenji beats in earning his place in the group. For instance, if a Basenji places first in group he would have to his credit one point for each hound shown at that particular show. If he were to place second in group with, say an Afghan winning first, then the Basenji would earn points for all hound breeds except those in Afghans. If a Basenji goes Best in Show, he would earn points totaling the entire conformation entry at that show.

The following tally includes all 1970 shows as published in the American Kennel Gazette, through the August issue.

WHITHER SHALL WE WANDER

As a comparative "tyro" in this show business of ours, I would like to write in speculation of this great big, wonderful world of our Basenjis; not as a professional - not exactly as an amateur, but as an in-between and an enthusiastic one.

Four years in the game does not qualify one for anything very much, apart from observation, attention to detail, and making manifold mistakes! To survive one year could be a feat in itself, depending, of course, what is at the other end of the lead. I personally, with hundreds of others, arrived in the show game by chance. A promising puppy, a desire not to let the breeder down, and a natural inquisitiveness to see what it was all about. In moments I was to wonder what on earth possessed me-firstly in buying a pedigreed pup, and secondly, sift through the complicated classes in order to enter my dog under so many scrutinizing eyes. At times I wondered if I was leading a donkey into the ring, because my pup's anatomy had undergone so many descriptions that I hardly recognized him as a dog at all! Happily for us, I soon arrived at the fact that any attention to him was complimentary and he was worth showing. That first Reserve Card was the greatest joy and pride, and although we have done much better since, I doubt if anything can supersede it.

From small beginnings my hobby began, and in no time at all it became the hobby and interest of my family also. From showing to breeding with more mistakes and keener desire to do better. Soon we were studying, observing, listening and learning until one day the realization that as potential breeders for the future we had a fair-sized responsibility to uphold the standard as best we could and produce and exhibit the best that was British.

But what are the most important points to strive for, and what should take order of precedence? Is it conformation, temperament, colour, movement or markings? Should a wellmarked animal with structural faults be set over an animal of ideal conformation, but less perfect in colour or marking? Ideally, all are important, but no perfect animal has yet been bred. Poor temperament eventually eliminates itself out of the show ring, and one hopes, out of the breeding programme - but often faults remain. Surely these faults will reproduce themselves whether they be structural or otherwise, but which are the most vital to eliminate and how can a determined breeder, (continued on next page)

HINT FOR THE NOVICES - Start very young in your nail-cutting routine, starting at one week old is best, and continuing every week thereafter, if possible, so that when the pups are grown they will be used to it and won't fight. Keep a supply of Kwik-Stop available to stop any bleeding immediately. This is a type of Styptic Powder and works very well. Don't be afraid to nick the quick (though don't try to) as it really doesn't hurt that much - it certainly won't do the dog much harm.

WITHER SHALL WE WANDER (concluded) aiming for the standard, set to work!

Obviously, no ancestry is free of imperfections and certain line-breeding can produce splendid results. The new breeder (or novice breeder) relies almost entirely on everything he can learn from the background breeding of the dog or bitch of his choice. If he is wise he assesses the virtues and faults of the breeding of the stud dog and bitch for the start of his breeding programme. He is bound to rely almost entirely on the integrity and honesty of the breeding partner involved, and once the progeny are born he is, in part, on his own. I say "in part" because a breeder in his aim towards perfection can never, in the interest of the breed, quite be on his own. Each one is dependent on the other to some degree.

The next step may be towards a good calculated outcross mating - once again relying on the clarity and honesty of the breeding partner involved. Patently, the new programme must be studied intelligently and unless the hidden faults are revealed and the pedigrees discussed in full - with all the discrepancies and virtues equally evaluated - no progress towards the ideal in temperament, conformation, colour, movement, and correct gait can properly be attained.

The show game is the breeders' shop window throughout the country and the world.

Ramblin' With Grannie Green

by Evelyn M. Green Box 3221, North Station, Meridian, Mississippi 39301

The main topic of discussion this month will be various aspects and opinions about breeding.

It is hoped that the selection of studs has already been made for our "ladies in waiting." To borrow an expression from the present-day generation, one does not breed for "bread" alone. Neither are "paper" (pedigree) breedings infallible to produce the best quality puppies. And let me hasten to add, at this point, I'm not knocking line-breeding. I am an advocate of it. Even in the most advantageous line-breeding there are other aspects to be taken into consideration. I am inclined to agree with a prominent judge, who prior to his being licensed to judge, produced many fine champions in his kennel, that the bitch is the dominant factor in reproduction.

With this thought in mind, the breeder must be certain that the bitch he is planning to breed to that "great" champion is equally good conformation-wise. This does not necessarily mean that she must be a champion. It is very important, however, that she does not have a bad fault which she can pass on to her progeny. Therefore we not only look at pedigrees for compatible line-breeding, but we look closely at the pair we are planning to breed. How do they balance physically. Will strong points be over-emphasized in the puppies? Will existing faults or weaknesses be worsened? No matter how carefully one breeds, scientifically or otherwise, not every puppy in a litter is a potential champion. But we can heighten that possibility through intelligent breeding practices.

About this time comes the question of culling in the kennel. There should be no more dogs in a kennel than can be properly cared for without overcrowding. No more than can be cared for efficiently and easily, so kennel routine does not become burdensome. This means sacrificing some of the overflow, offering them for sale or making other satisfactory arrangements. Bitches which are proven non-producers can be sold to homes where the owner is looking for a pet.

Above all, before you breed, be certain that you can adequately care for the prospective litters. This means proper whelping and puppy quarters which are isolated from the actual kennel. Take into consideration the available market for pups. A surplus of puppies which can not be sold equals an overcrowded kennel. How many puppies does the breeder feel he can market readily? Are there reservations on hand? Take all of these things into consideration in planning your litters.

Most of all, the goal of every breeder should be to elevate quality in his kennel with each breeding, every new acquisition.

KNOW YOUR FELLOW JUNIORS

"17 - 21 LIMBO?

"Recently, in "The Interlude," the monthly newsletter published by The Basenji Club of New England, I wrote a short article urging a bigger and better program for our juniors. Miss Denise Craven, the writer of this column read it and agreed with me. The majority of our local and national breed clubs, as well as our local kennel clubs are sadly lacking in the matter of good programs for our junior members. In a letter to me, she explained the situation that now exists, where junior is finished with their junior showmanship activities at seventeen years of age, and from there on until they are twentyone are more or less in a state of limbo. They are too old for junior showmanship, yet are too young to become full-fledged members of their breed clubs. There are exceptions to this rule, of course, but in most cases this holds true. When there are exceptions, usually a young person has to be at least eighteen before they are given full adult status in our clubs. This is a situation I am sure should be, and could be remedied.

"When a young person reaches the age of seventeen it is an impressionable time of their life, it is then the members of clubs should be giving the utmost of encouragement to our juniors. As it is now, our programs - such as they are - cease functioning for them entirely. True, any young person can continue to show their dogs in competition after they reach seventeen, but how about the rest of it? They cannot participate in their breed club activities, they are no longer part of the junior showmanship programs, the comradeship that is so much a part of breeding and exhibiting dogs is simply not there. Unless a young person has an unlimited enthusiasm to be part of the "Fancy," it is at this time they lose their interest in the entire matter. It is a rare occasion when one hears of a young adult who is interested in the breeding and exhibiting of purebred dogs is ever found among those young people demonstrating, raiding and looting, and participating in the diverse illegal activities practised by some of the younger generation today. A continuing program for our juniors after they reach seventeen is a much needed activity by all of the dog clubs. In addition to stimulating interest in our breed and clubs, there is no question that society as a whole benefits from young adults taking part in ALL dog activity. After all, if the Federal Government has seen fit to lower the voting age of our young people, why can't we do the same?

"Just what are the programs for juniors in the various clubs at present? It appears to consist entirely of listing the wins of our junior members in junior showmanship at the different dog shows. This is all very nice for the winners, and I agree they should be recognized, but what about all the juniors who participate and do not win? Should they be ignored? I am sure their interest and dedication is just as strong as the others. They also should get recognition for their efforts. Do the clubs give trophies and awards for junior showmanship wins. or for outstanding endeavors in the breeding of purebred dogs? Speaking from my own experience, I know of only one time that a junior was so honored by our Basenji club. A gold medallion was presented to a young lady at Madison Square Garden for accumulating enough wins to be invited to participate there in junior competition three years in a row. I am sure there are many more of our juniors who should receive recognition and awards from our club for the outstanding jobs they have done in breeding and exhibiting their dogs.

"One club, The Basenji Club of New England, has realized how deficient they have been in their past junior programs and has done something about it. They have created, as a start,



BASENJIS IN FRANCE

Once again we took part in the traditional annual, gala "La Belle Et La Bete," (Beauty and the Beast), held at Palm Beach-Cannes, and won a most magnificent trophy offered by Doris Van de Walle for our group of four Basenjis.

This most worthy charitable occasion is held in aid of the Union Protectrice Des Animaux de Cannes, founded by Lady Yule, an English woman, in 1877, comprising nowadays of several other refuge centres for dogs and cats; one of which is directed by the Basenji Club's own Vice-president, Madame Rocroy. This 'tres snob' social, as well as competitive event, is attended by a relatively large Anglo-American gathering which contributes generously to what is, of course, an otherwise entirely French philanthropic association.

The accent on judging this year was 50% for the dog, and 50% for the model, who is meant to look as much like her dog as possible. It is obviously difficult to look elegant at the end of several Basenji leads, but Adrienne did an admirable job, although unintentionally she had to parade in barefeet. Her pretty new silver sandals were - - - No! No! Not chewed by the dogs, but faultily stitched by the makers so that a vital strap broke when she put them on which meant there was no alternative but to forget shoes altogether.

The group was made up of BAMBI and GLOW, red and whites; little GUSTY, a tri; and SONNY, replacing his mother, DAISY (in season), and his first time out. This was so we could, for the first time, present all three colors together and we felt very flattered to hear the comment over the loudspeaker that - "A finer group than these magnificent Basenjis could be seen nowhere else in France!" I am, modestly, of course, inclined to agree for I am very proud of my family. We were very tired when we got home, but it was all so worthwhile in many different ways.

One was a seemingly providential encounter with a young Belgian gentleman who introduced himself to the dogs while waiting to make their entrance on stage. I say "providential," because I may not be able to find material for this column indefinitely.

where he continued to live for a number of years, and where he will probably be returning in the near future, although he is actually managing-director of an important establishment in Florida. What he had to say about our dogs and the breed in general exceeds any mere casual interest, and is food for thought for us all since it tallies with most of what was said last year by his fellow countryman who told us about the Balikwekwe (see December 1969 edition). He confirmed that in Swahili, the word "Basenji" was not flattering and denotes a "good-for-nothing" individual. But to quote him further:

"These dogs are very miserable in their African surroundings. They do have masters but are not fed, which means that they are prone to many diseases and have to fend for themselves. Their main source of food is the "simziliki," an animal described as mainly rat, but having a little of the rabbit about it. Quite large - about a foot long, and very tasty. The simziliki lives underground and as the dogs do not hunt below the surface, are caught and killed by them after much patient waiting. They also accompany their masters who hunt with spears and sometimes the odd old muzzle-loader, and their prey includes certain types of antelope."

The Basenji, as we know him, curls and wags his tail when he is happy and contented. If sick, or for some other reason, is temporarily miserable, he will let it go limp between his legs; or when he is relaxed or asleep on a chair he will hang it straight down. Much about his tail-curl therefore depends on his mood. The native dog's miserable expression may be nothing more than the frown we know so well, and are striving to maintain, or it could be due or accentuated by his miserable existence. What struck this gentleman most was the size of the dogs. "There," he told us, "they are much larger!"

So, dear A. B. Reeder, what are we supposed to think about all that, I wonder!



ANYONE FOR OBEDIENCE? by TAKU, C.D.

This month, let's take a look at why anyone might not be for obedience. Perhaps the first reason that comes to mind is that it takes time. It's a legitimate reason too, if two hours once during the week to attend classes, and not more than 15 minutes a day for the other 6 days is too much time. Sometimes it means taking the time to be with and work with your Basenji when you are so tired all you want to do is lie on the davenport. It's odd but when one forces oneself to make and spend 15 minutes with his dog it usually does more for that "tired feeling" than an hour on the davenport. There may be those who do not have 15 minutes a day plus one evening a week for their Basenji. Obedience is not for them.

Obedience is not for the people who have a Basenji just for "status." These people are apt to have the dog kenneled, handled and trained by someone else, and really want most to just show his trophies. They may enjoy talking knowledgably with important people about their breed, but they really do not enjoy the dog. This Basenji is not part of the family or the owner's life anymore than his sports car. Obedience is not for


Obedience with a Basenji is not for the person who lacks a sense of humor. The owner who can't stand to have his dog be smarter than he is may have some very depressing experiences, for the dog often seems to delight in doing just that! The person who must enter in obedience trials and who feels that a high score every time is essential, who blames the dog for every error, who can't relax and enjoy the teasing characteristics of the breed will do better to stay away from obedience with his Basenii.

Obedience with a Basenji is not for the person who just wants to add another title to the dog's name. It will prove frustrating to both the owner and the dog and be fun for neither. Sure, it can be done, but why go through the pain!

If obedience training isn't fun and a sharing of something special between the owner and his Basenji, they shouldn't

BASENJI SWEATER INSTRUCTIONS

Designed and patterned by Mrs. Floyd H. Clark 5915 South Milwaukee Way, Littleton, Colorado 80121

Materials: Knitting worsted, 8 ounces, 4 ply plus a small amount for contrast stripes if desired.

Needles: 1 pair, size 7, knitting pins, 4 needles, size 7 sock needles.

Gauge: 5 stitches = 1 inch. $6 \frac{1}{2}$ rows = 1 inch. Size: This pattern is for a 16 inch, 21 pound bitch.

NECK BAND: Cast on 54 stitches; row 1 K2 *P2, K2 repeat from * across; row 2 P2 *K2, P2 repeat from * across; continue alternating rows 1 and 2 for 3 inches, ending with P2. Alternate colors in bands if desired.

BODY: K18, increase 1 in next stitch; continue ribbing next 18 sts; increasing 1 st. in last st. K2, turn, slip stitch, inc. 1 st. in next st. as if purling; then P2; continue ribbing next 18 sts., P2,



inc. 1 st. in last st., P2, turn; sl. st. inc. 1 in next st. (K), K4, ribbing 18, K4, Inc. 1 in last st., K2 turn. Continue in this manner until all stitches are used on needle. There should be 36 sts. on either side of ribbing. This has made a half circle over the chest for fullness. Continue for 2 rows. Next K row, K36, turn, P36 turn, and continue in stockinette stitch for 6 inches, decrease one st. 5 times along the leg opening, end with a knit row. Cut yarn and attach to first of those on the other needles to continue with ribbing on next 18 sts. for 6 in. ending in a K row. Cut yarn and attach in order to work left side which is done in the reverse of the right side, end in K

row. Next row P80 across, keeping the ribbing pattern in the middle, next row K80 across, keeping the ribbing pattern in the middle. Continue in this manner and decrease one st. in the first st. on either side of ribbing as follows: every other row, for 5 times, then every fourth row 3 times. Continue those 64 remaining stitches until total length along back is 14 1/2 in., ending with a P row. (The decreases take care of the necessary fit for the 'tuck-up'). The first 23 sts. will begin right side of rear leg. K23 sts., turn, P23 sts, continue in stockinette until leg opening measures 1 in; on P row P22, turn, sl. st. K next 21 sts., turn, P20 Sts., turn sl. st., K19, continue in this manner until all sts. remain on right needle. Cut yarn and attach to first of those on other needle to continue with ribbing on next 18 st. for 4 1/2 in. (this is where those knitting for a male would make an adjustment). Cut yarn and attach in order to work left side which is done in the reverse of the right side. Cut yarn, leave stitches on needle (they will all be on the right needle).

LEGS: Cast on 16 sts. on sock needles distributed 8 on 1st needle and 4 on the other two. Work in ribbing pattern 2 inches. On last st. of last row, inc. 1 st., then inc. 1 st. on first st. of next row, repeat at end of 1st needle and beginning of 2nd needle, Knext row, then continue increasing every other row as above until you have 60 sts. (increases will make a seam at front and rear of leg piece). K one more row, then weave in place having picked up 30 sts. on each side of one front leg opening on extra needle. On rear legs leave 5 sts. beyond end of ribbing and 7 sts. on outside of leg to be picked up on the band around the tail.

BAND AROUND TAIL: Knit all stitches in ribbing pattern for 3/4 in., picking up the 12 sts. from each leg with the first row. Cast off!

Sew in 20-inch open end zipper, with the open end at



SOME BASENJI FIRSTS

compiled by JoAnn E. Burton 1075 N.W. Saltzman Road, Portland, Oregon 97229

(Any errors are my own and I welcome positive corrections)

3600 B.C. (about) First dogs ever depicted in Egyptian tombs were Khufu dogs of Basenji type.

1895 First time Basenjis were imported into England and exhibited. These dogs contacted distemper and died. Also there were two Basenji in Paris at this time.

1936 First successful importation of some of the foundation stock of today's Basenjis by Mrs. Oliver Burn of England - BONGO, BOKOTO and BEREKE OF BLEAN.

1937 (February) First successful exhibition of Basenjis at Crufts Coronation Dog Show in London. This led to world recognition and interest. These Basenjis were probably out of BONGO and BOKOTO OF BLEAN.

1937 First Basenji in the United States - BAKUMA OF BLEAN, later registered as PHEMISTER'S BOIS.

1940 First Basenji Champion in the world - KWILLO OF THE CONGO, owned by Dr. Richmond of Toronto, Canada.

1941 (August) First litter raised to maturity in America, out of PHEMISTER'S CONGO and the male, KOODOO OF THE CONGO (Canadian).

1942 (about) First United States litter raised to maturity by a U.S. male - PHEMISTER'S BOIS, out of PHEMISTER'S NAIDA (daughter of PHEMISTER'S CONGO).

1942 First C.D. and C.D.X. Basenji - PHEMISTER'S BARRIE, out of PHEMISTER'S CONGO x KOODOO OF THE

- First American Champion - PHEMISTER'S MELENGO.

1946 (about) First Basenji brace to go Best in Show -CH. PHEMISTER'S MELENGO and her dam CH. ZINNIA OF THE CONGO, C.D.

1947 (February) First English champions - BROWN TROUT and FERN OF THE CONGO (littermates, owned by Veronica Tudor-Williams).

1947 (April 17) First Tricolors born in the Western World - BLACK MAGIC and BLACK IDOL OF THE CONGO (by BROWN TROUT, out of FERN.OF THE CONGO).

1947 First tricolor in the United States - BLACK IDOL OF THE CONGO imported from England to Mary McWain of New York. (IDOL died of leptospirosis two points short of Championship).

1952 First Hound Group Winner in the United States -CH. BLACK MIST OF THE CONGO, owned by Miss McWain.



LEARN BY DOING, BEST PREPARATION FOR CAREER IN DOGS

by Gaines Dog Research Center 250 North Street, White Plains, N.Y.

How do you go about preparing for a career working with dogs?

There's no prescribed routine. With a few exceptions, there are no schools or other formal means of becoming a dog breeder, trainer, handler or groomer. Most of the exceptions are in the latter category, with schools of dog grooming in several metropolitan areas.

Working with dogs is a situation where experience is the best teacher. One of the best places to develop background knowledge is the public library. Read everything available on dogs: care, training, appearance and performance desirable in the various breeds. Don't confine your reading to dogs, per se, branch out to related topics: genetics and animal nutrition, for example.

Attend dog shows, field trials, in fact, any event involving dogs. Become acquainted with exhibitors and handlers. You'll find much can be learned about dogs, even in casual conversation with the experts.

Observe dogs working in field trials or being judged at shows. Evaluate quality and/or performance, then compare your decisions with the judge's appraisals.

Join a local kennel club or field trial organization. You may not be an exhibitor, or a dog owner for that mat-

ter, but there are many ways to be a valuable member. At the same time, you'll meet people and be in situations that increase your knowledge.

OBEDIENCE TRAINING IMPORTANT If you own a dog, join an obe-

dience training club. Classes usually are open to crossbreed dogs, as well as purebreds. A good many advantages are gained by participating in obedience training. You'll have a well-mannered pet. Lessons learned from working with your own dog are applicable to other dogs. And much general expertise can be absorbed from the instructor.

Purebred dogs, listed with the AKC registry, can be entered in dog shows or field trials, whichever is suitable to your interests and the dog's breed and training.

Your dog may be a less-thanperfect show specimen or performer in the field. Just the same, exhibiting him give invaluable experience in conditioning, training and handling for competition, as well as in field trials and show procedures.

Most dog shows have junior handling classes for children and teenagers. Judging is based on the handlers' abilities. Quality of the dogs does not count, although they must be purebreds.

Field trial and kennel clubs often sponsor 'fun' matches, shows or

trials usually geared towards novice exhibitors and dogs. These informal competitions are another good way to gain experience.

If your goal is becoming a professional groomer, try to attend a school of dog grooming. If this is not possible, study the American Kennel Club approved breed standards. This will familiarize you with the ideal appearance of the different breeds. Then go to shows where you'll see expertly groomed dogs. There are many books giving step-by-step instructions for various types of coats.

Are jobs available with a dog groomer or kennel in your vicinity? If you're fortunate enough to find such a position it will be an excellent way to acquire grooming skills and to learn about dog care and management. There will also be opportunities to see the business side of running a kennel-this is important too.

Of course you'll probably begin by helping with the day-to-day tasks. Don't underrate the job. It's an ideal way to start. And like any other field of endeavor, your responsibilities will increase with knowledge and skills.


