

This combination of assets allowed him to speedily finish his American championship, earning his majors at Goshen and Westbury, two supported shows. JOLLY JOKER earns his name - a sweeter but nuttier Basenji has never been seen. He will not appear in the specials ring until he learns not to treat it all like fun and games. Right now he is in Canada to get his Canadian title, and join his mother, uncle (Am. Can. Ch. Katanga's War Lord of Bomar), and grandsire (Am. Can. Ch. Rose-Bay's Gay Blade, Am. Can. C.D.) and Am. "EMMI" winning a group one

This second letter concerns an experience of this past week which was extremely upsetting to both my husband and myself. We had learned from a local, small Basenji breeder that there is a puppy mill nearby. We had heard a great deal about these puppy mills and have been following the articles in "The Basenii." so we decided to see for ourselves. It made us ill!

Small breeds are kept in tiny crates; large breeds in closed-in areas in a barn, and the medium breeds all mixed up in 4' x 5' areas. What hurt the most was a pair of Basenjis that were starved for love and affection. We were allowed to see the bitch's registration slip and the dog's pedigree. His backgroung is good, but he has no curl in his tail. The bitch has good conformation, but poor coat color. Both need a great deal of exercise. We talked at length to the owners, trying to discourage them against keeping the Basenjis, mainly using the one season a year and puppies seldom ready for sale by Christmas angle. The owners would not consider selling the 4-yearold dog as they use him for stud, but are willing to sell the year old bitch at show price.

It was difficult to turn away without buying, if only to see them out of such a place. What can concerned dog people do about these puppy mills?

I am wondering too if local Basenji owners are aware that the Brookfield Zoo in Chicago has a Basenji. INGA, the barkless dog! She is in the Children's Zoo in a type of pit that has an island of dirt and rock built up in the center. For shade she has a piece of canvas stretched over four poles. She is a young bitch and is pet stock, but it seems a shame she has no family for love and companionship.

I cringe at the way I have seen Basenjis treated this past week.

## HOUND OR TERRIER



As one who has bred, shown and judged both Terriers and Baseniis over a period of many years, I would like to be permitted to comment in detail upon the current controversy which has arisen from the decision of the canine authorities in France and Italy to include Basenjis in the Terrier group.

May I begin by stating that although I believe there is an adequate case for suggesting that the Basenji belongs among the hounds, the examination of this question must be undertaken dispassionately and objectively. No authoritative body is going to be impressed with emotional attitudes and inaccurate generalisations which cannot be sustained. Let us accept also that there is no onus upon the ruling body in canine affairs in any country to accept the same groupings of breeds as other countries, since in any case the inclusion of a number of breeds in almost every group is obviously to some extent arbitrary. There are, for instance, differences between the British and American groupings. The Miniature Schnauzer is not a member of the Terrier group in the United Kingdom, although it has obvious visual similarities. The word "terrier" is reputed to be derived from the Latin word "terra," signifying the role of such dogs in going to earth after vermin, and this, of course, was the original role of Terriers, and still is of some. The modern grouping, however, seeking to deal with the proliferation of different breeds arising from experiments using the original Terriers crossed with other breeds to produce a much greater variety for a multitude of purposes, is a very loose arrangement, having more to do with origin and visual appearance than with the function of many modern Terrier breeds. The use of the Otterhound in producing the Airedale, and the Bulldog to produce the Bull-Terrier, and Staffordshire, were obviously designed to produce dogs with very different purposes than going to ground. In the case particularly of the last breed, the standard calls at most points for characteristics which are completely contrary to those desirable for most other Terrier breeds, particularly the "classical" Terriers if one may use that term, such as the Fox Terriers.

With great respect, and with sympathy for her obvious concern, it seems to me that Genie Rundle, in her article in the June issue, has been led by her anxiety into a number of insupportable generalisations and irrelevancies which might lead to a weakening of her case if it is presented in similar fashion to the canine authorities. May I be more specific. From her Webster's definition of Terriers, most of the attributes quoted, e.g., "generally small, vivacious, intelligent and courageous, and useful in hunting some kinds of game" would in fact fit the Basenji very well. In other words the Basenji fits this description far better than many breeds already included among the Terriers! She goes on to say, "Imagine a Bedlington expert judging a Basenji." In fact, this is commonplace in the United Kingdom, and I suspect the all-rounder judges in the United States often are specialists in Terrier breeds, and gained most of their experience with such breeds, often never owning a Basenji.

Nor is it permissible to generalise about temperaments. Otherwise, what about all the talk which has gone on, and the concern which still persists for Basenji temperaments? Terriers are not, in fact, all noisy, aggressive and unsociable any more than breeds from any other group. I have often heard as much noise from Elkhounds for instance, and occasionally from Basenjis as from any of the Terrier breeds. One hears very little fuss from Bedlingtons, Dandies and other Terriers I could mention, and I have seen many kennels where mixed groups of Terriers have run happily together. As for sociability, one of the appealing characteristics of the Basenji at times is

his aloofness and independence of spirit, and there is no breed gentler with children and families generally than the fierce looking Staffordshire Bull Terrier. We cannot therefore, afford to be superior on this account. Mrs. Rundle's observations on differences of type within the breed raise a problem which besets every breed I know, but one which would appear not to have great relevance to the main issue since it is a matter which must be dealt with mainly by dedicated attention to it by the Basenji breeders of each country.

All that I have written above is not to deny that there is a case for the Basenji to be designated as a hound, but to clear the issue of misconceptions which cannot be adequately substantiated. What kind of case, therefore, is left to us? I would suggest there is still a strong one which I would like to state below in tabulated form:

1) It seems chauvinistic in the extreme for the F.C.I. to ignore the fact that in the two countries where the Basenji has been developed as a show dog from its primitive origins, where the largest number of Basenjis exist, and whence the foundation stock for other countries emanates, the Basenji is classified as a hound. I have seen no good reasons published by the F.C.I. for a contrary view, so cannot understand why, on grounds of international uniformity and administrative convenience this should not be taken into account.

2) Although I have stated above that there is a great deal of divergence in present function between different Terriers, there is a general origin from the common Terrier of pre-show days, and the Basenji does not fit into this category.

3) The pure Terrier, ignoring much modern usage, was bred as a killer, originally going to earth to finish the job after the hounds had run their quarry to earth. Even now, the job of most Terriers is either this, or to fight, to destroy vermin, or as in the case of the Airedale, to guard. They are not required to run and bound at speed, or to round up fast moving (continued on page 26)

## LONDON LIMELIGHTS

THE LIMELIGHT shines this month on Miss Veronica Tudor-Williams. In the shadow of the limelight trots little FULA, complete with crow! This was a long awaited visit after having met Veronica at many of the shows, and after having seen her judge the Hound Association show in July. Visiting with someone in their home is much nicer than just having a few stolen minutes at a busy show. This visit was no exception.

To be able to sit down with someone like Veronica and talk of the early days in the breed, is such a rare opportunity in today's busy world. Everyone is well aware of a lady named Veronica Tudor-Williams, but few get to know her as she really is. An energetic, lively woman who is much younger than her years would indicate. At 72, she prances around the ring like a 27-year-old, and loves every minute of it. Viewing Veronica in person is quite different from seeing her in her book, "Basenjis The Barkless Dog." She is closer to 5 feet, and 85 pounds than her photos would have you believe.

Miss Tudor-Williams is a dog world legend in her own time, and yet she isn't particularly aware of the fact. She continues to write a weekly column for the English dog paper, "Our Dogs," and does an occasional column for this magazine.

FULA is now getting on in years and being a native bred and born dog, she is quite different in many ways to the kennel bred and born dog. Little FULA had to have countless shots before arriving in England, and while she was in quarantine, for abscesses caused by maggot flies. Still later she got another countless number of shots for a calcium deficiency following a litter of pups. At one point during the treatment she decided she had had enough, and to this day she is very leary of people's hands. With us she was marvelous. Trotting around and crowing like a pup.

"In 1940," says Veronica as she produced her scrapbook of momentos, "Some British people were very angry that dogs were being fed food intended for people. To subdue this outcry, I wrote to 'Our Dogs' suggesting that we dog people buy a Spitfire (famous WW II fighter plane). This was done, but unfortunately it was shot down."

As BINZA, the tiger striped dog brought out with FULA in 1959, was of interest to me, we talked at some length about him and his descendents. We also saw a great many slides taken during the 1959 trip into Zande country (Southern Sudan)

of clearly defined tiger striped dogs. It doesn't seem right somehow that the original standard managed to carry qualifications for the tri and black and white (when we had neither of them) and not the true tiger striped too.

The Tudor-Williams' home is situated on the banks of Thames River, Excepting for an occasional plane flying overhead, it's a very peaceful scene with all the boats sailing up

Veronica has been very busy redecorating her home. and is doing a superb job of it. Lovely old furniture, which I have a fondness for, and her favorite paintings hanging on the walls. Plush green carpeting and off-white walls. The house radiates Veronica's personality.

She has so much kindness in her heart. She is the children's Queen because she twists their arms to eat more cake and candy. This critique from our Kathy.





## The Magnolia Basenji Club

See results in the show reports. Besides the many nice wins in Carolina, word has been received that the Websters' AM. CH. UBOMBO OF HILLS HALF ACRE completed his Canadian championship. Congratulations!

We hope everyone who possibly can, will make the Atlanta show and BCOA Southern Specialty. The plans sound great and the various committees are working hard. It will be a real fun time.

Old-timers can skip the rest of the column this month as it is written mainly for exhibitors who are showing for the first few times. Last month (thanks to George C. Jones, III) we discussed grooming and it can't be stressed too strongly that show dogs be presented in a clean condition. Even if one does not know the fine points of grooming, the dog can be

As for the actual showing, we shall suppose that you have attended dog shows and have some idea of what is required once you enter the ring with your Basenji. Even if you have the best dog entered, don't expect to win all the time, nor should you have the negative attitude that you couldn't possibly win as neither you nor your dog will show to the best advantage. If you have done your homework faithfully and have a reasonably presentable specimen of the breed, you will have the same chance to win as everyone else.

Now the homework. If possible, try to have the dog enjoy his training so he will not be bored or lackadaisical. This can come about by your attitude toward training. Go out

\$\_\_\_\_\_ there like this will really be a "fun time," and your dog will have the same attitude. First, and the earlier the better, make certain that he becomes accustomed to some sort of restraint around his neck without his resenting it. This may take several days of patience on both your parts. Do not force or hurry, particularly in the early stages of training. Once he becomes adjusted to the collar, add a lead and practice gaiting with the dog's head held up (no sniffing). With a young puppy, just attach the lead and let him play with it and drag it around until he gets used to it. (Do this early training off by yourself where there are no distractions of his littermates, or other dogs). Dog should be at your left side. When they are older, 3 to 6 months (depending on how much training they've had as young pups), have someone watch you and tell you at what rate of pace the dog shows to his best advantage. Some judges will ask you to slow down, and some will ask you to speed up, but you should know your dog's best gait and use it when you can. About ten minutes a day practice should do it. Keep the collar (or show lead) high on his neck so he will not choke constantly and do not try to hold his head higher than is comfortable or he will not gait with the free swing he's supposed to have.

When you enter the ring and everyone is settled in place, the judge will usually have you gait your dog along with the others in the ring. This is partly to get the dogs in the proper mood and also for general comparison. After going around the ring, you will be told to stop and set your dog up for examination, in line with the other entries. (More on how to do this in a later issue). Presumably, the judge will check each dog for soundness, bite, tail and ear set, coat condition, angulation, etc. And in the case of males, he also checks their underpinnings. The dog should remain quietly in place throughout the examination. Then you will be asked to gait your dog individually following the route the judge tells you. Sometimes it is just up and back, away from, and toward the judge, and (continued on page 25)

I manage to cause comment on ring procedure whenever I judge. At the EBC specialty I asked all exhibitors to come into the ring in catalog order. Why? I have several reasons, not the least of which is that I have a great dislike for a pile-up at ring entrance with an unseemly haste to be first on the part of some exhibitors. I also had the ring steward announce that I wanted the exhibitors to show me the bite. I don't care to carry germs from one dog's mouth to the next.

Also a dog that rumbles deep in his throat will draw an admonition from me, but the dog that snaps or tries to bite is summarily dismissed from the ring. Judging is not a test of physical courage, and temperament is my first consideration when it comes to judging any breed. Then we'll talk about type and soundness.



Is there any difference?

Minimum prices will be set by the general membership, for puppies. During the puppy season, the club will place an advertisement weekly in the largest newspaper, listing the club and a member's telephone number who can relay all puppy information to prospective buyers, so as to show a united Basenji market to the public.

Hopefully, these revisions will pull our Basenji people in the Atlanta area closer together and be a real step in bettering our breed.



## PERSISTENT PUPILLARY MEMBRANE AND ASSOCIATED DEFECTS IN THE BASENJIS

The BCOA Eye Committee would appreciate it very much if you would reprint the enclosed article. It's the first article by an English research team to come to our attention, and we feel it would be interesting to breeders.

SUMMARY — Persistent pupillary membrane, an inherited ocular abnormality, is recorded in the Basenji in Great Britain. It is due to a dominant gene with a wide range of expression affecting structures in both the anterior and posterior segments of the eye, including pigmented stumps in the region of the lesser circle of the iris and strands crossing the pupil, colobomata of the iris, opacities and spots in the cornea and fragments on the posterior cornea, congenital anterior synechia, microcornea, cataracts and pigment patches on the anterior lens capsule, colobomatous cupping of the optic disc. All these defects may be classed as typical colobomatous defects, varying considerably in severity and only rarely affecting vision.

#### INTRODUCTION

The pupillary membrane is a sheet of mesoderm carrying a network of anastomosing blood vessels, covering the anterior surface of the lens, and formed during the development of the eye. It forms the very thin and almost acellular central part of the lamina irido-pupillaris, or posterior wall

of the anterior chamber, the peripheral portion of which remains permanently to form the superficial layer of the iris (Duke-Elder, 1963). Atrophy of the pupillary membrane commences in foetal life, but not uncommonly parts remain into adult life and may then be spoken of as a persistent pupillary membrane (p.p.m.).

Following the report (Roberts, 1967) of this inherited ocular defect in Basenjis in America, breeders in this country were anxious to have their dogs examined to ascertain whether this condition was common in their breed in Great Britain, if so to find sound stock for breeding, and also to discover if p.p.m. was a serious cause of defective vision, as at the time there were rumors of many dogs blind because of this condition.

#### MATERIALS AND METHODS

A total of 222 Basenjis have been examined. Approximately the same number of dogs as bitches, and all the accepted coat colours. Ages ranged from 4 weeks to 14 years. Complete litters of puppies have been seen and a number of these have been examined on several occasions up to 12 months of age, and the normal post-natal atrophy of the pupillary membrane in the Basenji compared with Labrador, Border Collie, Boston Terrier, Greyhound, and cross-bred litters.

The method of examination was found to be a most important factor in the diagnosis of this condtiion. Naked eye examination is inadequate and for this reason very many cases go unnoticed by owners and breeders, and only animals with large corneal opacities and severely defective vision are recognised. Direct ophthalmoscopy reveals many cases, but not all, and a slit lamp binocular microscope is the best and most reliable method. Although slip lamp examination may not be a practical proposition in all cases, in the future it would be wise to use it during the examination of all dogs found negative by direct ophthalmoscopy, particularly if certificates are to be given for future breeding stock. Anomalies occurring within the width of the iris are best seen when the pupil is constricted. The strands crossing the pupil are most obvious when viewed against the tapetal reflection and when the pupil is dilated. When the pupil is constricted these strands sag and may be hidden, but when the pupil is dilated they become taut and thus more obvious.

In addition to the wide range of colobomatous defects affecting both anterior and posterior segments of the eve, there is a considerable variation in the severity of the individual lesions and often a pronounced difference between the two eyes, although both invariably show some defect, however slight. This is very similar to the situation existing in the Collie eye anomaly (Barnett, 1969). In all our cases vision was very rarely affected and in spite of many instances of p.p.m. and congenital anterior synechia the pupil was usually normal in shape and movement. It was only in the few cases showing severe colobomata of the disc and extensive corneal opacity that sight was known to be defective, and we feel it important to stress this fact because many breeders thought that p.p.m. was the cause of several cases of blindness. However, the minor manifestations are important and must be recognised when choosing future breeding stock.

P.p.m. and associated colobomatous defects are inherited in both man and animals, and if the wide variations are all classed as typical colobomata and considered together from a genetic point of view the mode of inheritance follows a dominant pattern and there is no sex linkage. The gene has a wide range of expression, leading to the many different defects, and it has also been suggested in man (Duke-Elder, 1964) that the gene varies considerably in its penetrance so that sometimes one of more generations are missed-transmission may therefore be considered as irregularly dominant and the study of pedigrees of all our cases has shown that this is very probably the case in the Basenji. Certainly we have had no evidence of a recessive gene, colobomatous defects have been seen in

four generations in one family, and males and females are equally affected.

The pupillary membrane in dogs is still present when the eyes open and can be seen quite clearly in puppies between two and three weeks of age (by this time the cornea has cleared a little) as a fine network in the pupillary area. Atrophy of the membrane usually occurs at three weeks of age commencing from the centre of the pupil and leaving a few strands visible around the edge, finally these disappear between 3 to 5 weeks of age. An attempt has been made to compare the normal atrophy of the pupillary membrane in the Basenji with other breeds and it would seem that in the Basenji atrophy does occur about 2 weeks later, although some strands may well atrophy at a much later date. It is known in man that if strands of p.p.m. remain beyond the first year of life they are likely to be permanent. From these facts it would be wise to delay the examination of puppies for evidence of this anomaly until at least 2 months, and wherever possible 3 months of age. In man p.p.m. and other colobomatous defects of the eye are often associated with anomalies of other parts of the body, and it is interesting that the Basenji has been recorded as having a high incidence of inherited inguinal hernia and midline defects (Fox 1963). It has been stated above that colobomata are due to a disturbance in the closure of an embryonic cleft and a significant number of the Baseniis we have examined with eye defects have also had umbilical herniae. Dental anomalies have also been recorded in man, and one Basenji examined had minor colobomatous eye defects and missing second and third upper pre-molar teeth on one side.

ACKNOWLEDGEMENTS — Many breeders of Basenjis have been only too willing to have their dogs examined, often on several occasions, and have been most helpful in providing pedigrees. Many articles have been written on the ethics of breeding, and offering stud services. One practice I question is if an owner should offer his dog to outside stud. This is a point that should be most carefully considered since a heavily used stud dog will exert great influence on his breed. Because an animal is a top winner in the show ring and is able to throw his type, does not necessarily make him the ideal dog to be used at random with outside bitches.

A dog is like a tree - a good deal of him is there for all to see and appraise, however, like the tree, the greater part of him is hidden under the surface in his body structure and genetic makeup. A conscientious owner will strive to determine if his dog is as free of hidden faults as possible before offering him at stud. If it is discovered that such an excellent animal does possess some flaw, he should be used with extreme caution and his puppies carefully controlled. This way the good that this dog has to offer can be retained for the breed without spreading his faults far and wide. If such a dog is used with an outside bitch, the bitch's owner should be warned so he can make the decision as to whether to take the risk or not. One breeder has won my respect for just such an unselfish







## SKIN PROBLEMS IN DOGS

by R. W. Kirk, D. V. M.

Skin diseases of dogs may be caused by external or internal factors, and many conditions are made worse by harsh dips, baths or lotions. A veterinarian attempts to diagnose the problem by observing the specific skin lesion (pimple, scab or scar) and noting its pattern of distribution. Owners can be most helpful in describing when and how the disease started and how it progressed. Itching is a major problem of many skin diseases, some of which are more difficult to treat. Allergies, parasites and atony are major causes of scratching.

Flea collars have been effective for 90% of dogs in alleviating parasite problems. However, about 10% of dogs are sensitive to them and severe skin reactions may develop in these animals. If the collars are used improperly skin reactions may also develop.

Demodectic mange is one of the "monsters" of skin afflictions. Simple cases respond well to treatment but complicated ones may be incurable. Dogs with this problem often develop secondary staphylococcal infections which further complicate the disease. The parasites may be contracted by the pups' nursing dam, and hence it's a real problem to breeders raising pups for sale. No real "cure" exists, and although some research is progressing, no complete understanding of the disease problem exists.

Bacterial infections of the skin - especially of the nose and feet - is also a serious problem. Afflicted dogs seem to have poor native resistance to infections and cures are often difficult and expensive. Certain breeds seem predisposed to this and to other special types of skin disease.

Diet has long been considered to be important as a cause or as a cure of various skin problems. In fact, this is rarely true. Extreme conditions may have an influence on the animal's coat, but hereditary factors, environment, and general care are usually much more important. A well balanced, varied diet is usually adequate to produce a good coat and good skin

It is a trite phrase, but true - the skin and coat are mirrors of the dog's general health. Without basic good health the skin cannot reflect the "glow" that is so desirable.

## Thoughts Provokin'

I am disappointed in you. Some months ago I mentioned that dog fanciers were discriminated against and urged a hard campaign to secure equality for our animals. I cited the various regulations placed upon dogs - rabies inoculations, licenses, leash laws, confinement to own property, etc., and you seem to have taken this not at all to heart. As a result you might be interested to note what has been happening in the world while you sat and watched.

A recent issue of a large metropolitan newspaper carried an advertisement 2 columns by 8 1/2 inches for something called "The National Cat Protection Society." Now 17 column inches in a major newspaper is nothing to purrat. The ad went on to say that of the 40 million cats in the country, only 22 million had homes - leaving 18 million to fend for themselves, and said that only one out of six would ever find homes. Hidden near the end of the eight listed objectives of this society was their number 7 which read: "Introduction of laws to protect felines and guarantee their rights." What rights? The right to kill birds? The right to sadistically torment mice? To claw trees and shrubs? To befoul the air with their stench? Aren't there anti-pollution laws to protect the humans from such evils?

Listed among the honorary vice presidents were the names of a U.S. senator and a former wife of a movie star both reasonably well known. What have you done to protect and advance the interests and rights of the canine world.

It is a very serious problem. If this spreads just think what could happen if the hamster owners and the rabbit owners to say nothing of the mouse owners, join forces and demand, perhaps by means of a march on the White House and a demonstration in front of the Supreme Court, the protection of their species and the guarantee of their "rights." Why if this were allowed to happen we'd be up to here in hamsters, rabbits and mice. Shades of a book of some years ago entitled, "Pigs is Pigs," written, I believe by Chic Sales. A most potent argument in support of my own proposition, is this old story.

So you see we have glamour in the guise of a former wife of a movie star, and legislative power in the form of a U.S. senator, working against us in this matter. Not that we want to eliminate or dominate the other species, but surely we can demand "equal rights." Isn't it about time we did?? Have you started at the local level and written your city or county officials about their discrimination against the canines? Don't you think it high time you did?

Should you think this a laughing matter, check about a bit and see what regulations apply to dogs and to kennels. Then see what regulations apply to other varieties or species and to catteries, fisheries, aviaries, apiaries, mouse-eries (or is it mice-eries?) and all other types of preferred, segregated

Oh yes, the N.C.P.S. which placed the ad made note that it is a "bona fide non-profit, charitable organization" and that your gifts were tax deductible. So you, dear canine loving taxpayer, are footing the bill, in a sense for this organization which wants to guarantee rights for felines. And presumably, the preferred and discriminatory treatment they received while canine fanciers must pay and be restricted.

Aren't you tired of having your dog classed as a second citizen? Do something - NOW - before it is too late. Don't laugh, remember they laughed at Orville and Wilbur and now you can't stand the noise of jet aircraft, and they laughed at the first "horseless carriage" and today it is killing us rapidly by accidents: over 50,000 per year - or slowly by air pollution from exhaust fumes or by slaughter of sea life from tanker carrier crude oil.

It's later than you think, Don't just sit there - ACT!

sometimes he will have you gait in a triangular pattern. When you return to the judge he will expect the dog to be alert to any sounds he may make with keys, etc., or bait him yourself. After each entry has been examined separately, you usually gait around with the others again, and hopefully, you are in the ribbons for your class.

Please remember to have your name on the photo itself.

To get back to the stand-for-examination - after your dog has practiced his gaiting, repeat the word "stand" until he knows what is expected of him. And don't forget the praise when he does something right, or even half right. You get so much better results with praise than with angry orders with Basenjis, plus the bonus of having a happy worker. Here again it is helpful to have someone look at his teeth and to press gently on his back. Mouth examinations can be done at anytime and the dog will become accustomed to it, and will not resent it. Male organ examinations can also be done more frequently, but gently please. At no time should the dog be so handled that he will resent others touching him. In standing the dog, many times all that is necessary is a gentle tug on the lead and then checking to see that the hindquarters are set right. If the topline of the dog does not appear level, try various foot positions until you approximately achieve this goal and then recheck the feet to make sure you don't spread them too much. Don't fuss constantly with the dog once he is set up or you both will be too jittery.

Next month we will discuss the various classes in which you can enter your dog. If there are dog training classes in your area, do attend with your dog and the shows will come easier. Also participate in all matches that you can.



4) Characteristics generally required in Terriers are heavy bone, greater development of rib cage, and general cobbiness. The Bedlington with its flat sides and roach is to some extent an exception to this, but this may derive from the use of the Whippet, and places this breed as it were on the fringe of Terrier type, with a number of hound characteristics. The general elegance and fine bone of the Basenji would seem to make it a very uneasy member of such a group, but appear to be much more at home in a line-up containing the Whippet and

5) The Basenji obviously has considerable affinities with the "Spitz" breeds such as the Elkhound, and the Finnish Spitz (allowing for differences occasioned by habitat) and both these breeds are in the hound group in this country.

6) Finally, even if we admit that there is considerable diversity in the hound group, again arising from selective breeding for specific purposes, such as in the Basset and Beagle, with their sturdiness and heavy bone, and the Bloodhound, if one places such breeds as the Afghan Hound and the Saluki in the hound group (and who can imagine otherwise) there can be no justification on grounds of function alone, for not also including the Basenii.

I suspect, however, that in spite of all this historical and analytical argument, the reaction to it of any Basenji who understood what was going on would be to yawn with that brand of superior resignation which is so typical, and curl up a little tighter in the best chair. I can't really see how, in the long run, it makes very much difference to the dogs themselves which breeds they stand with for the group judging - a good Basenji despises them all!


YIPEE! We made it - a 5-point major show at Florence, Kentucky, July 19. The BCOC takes a well deserved bow!






